

Pulsating semi-waves in periodic media and spreading speed determined by a free boundary model [☆]

Abstract

We consider a radially symmetric free boundary problem with logistic nonlinear term. The spatial environment is assumed to be asymptotically periodic at infinity in the radial direction. For such a free boundary problem, it is known from [7] that a spreading-vanishing dichotomy holds. However, when spreading occurs, only upper and lower bounds are obtained in [7] for the asymptotic spreading speed. In this paper, we investigate one-dimensional pulsating semi-waves in spatially periodic media. We prove existence, uniqueness of such pulsating semi-waves, and show that the asymptotic spreading speed of the free boundary problem coincides with the speed of the corresponding pulsating semi-wave.

1. Introduction

We are interested in the evolution of the positive solution $u(t, r)$ ($r = |x|$, $x \in \mathbb{R}^N$, $N \geq 1$), governed by the following diffusive logistic equation with a free boundary:

$$\begin{cases} u_t - d\Delta u = u(\alpha(r) - \beta(r)u), & t > 0, 0 < r < h(t), \\ u_r(t, 0) = 0, \quad u(t, h(t)) = 0, & t > 0, \\ h'(t) = -\mu u_r(t, h(t)), & t > 0, \\ h(0) = h_0, \quad u(0, r) = u_0(r), & 0 \leq r \leq h_0, \end{cases} \quad (1.1)$$

where $\Delta u = u_{rr} + \frac{N-1}{r}u_r$; $r = h(t)$ is the free boundary to be determined; h_0, μ and d are given positive constants; $u_0 \in C^2([0, h_0])$ is positive in $[0, h_0)$ and $u'_0(0) = u_0(h_0) = 0$; the functions $\alpha(r)$ and $\beta(r)$ are positive and satisfy the following conditions:

$$\begin{cases} \text{(i)} & \alpha, \beta \in C^{v_0}([0, \infty)) \text{ for some } v_0 \in (0, 1), \\ \text{(ii)} & \text{there exist positive } L\text{-periodic functions } a \text{ and } b \text{ in } C^{v_0}(\mathbb{R}) \text{ such that} \\ & \lim_{r \rightarrow +\infty} (|\alpha(r) - a(r)| + |\beta(r) - b(r)|) = 0. \end{cases} \tag{1.2}$$

Problem (1.1) may be viewed as describing the spreading of a new or invasive species with population density $u(t, |x|)$ over an N -dimensional habitat, which is radially symmetric, heterogeneous and asymptotically space-periodic near infinity in the radial direction. The initial function $u_0(|x|)$ stands for the population in its early stage of introduction. Its spreading front is represented by the free boundary $|x| = h(t)$, which is a sphere $\partial B_{h(t)}$ with radius $h(t)$ growing at a speed proportional to the gradient of the population density at the front: $h'(t) = -\mu u_r(t, h(t))$. (A deduction of this condition based on ecological considerations can be found in [6].) The coefficient functions $\alpha(|x|)$ and $\beta(|x|)$ represent the intrinsic growth rate of the species and its intra-specific competition respectively, and d is the random diffusion rate.

Problem (1.1) was studied recently in [7], and when α, β are positive constants and the space dimension is one, this problem was considered earlier in [10]. In both cases, it was shown that a unique solution pair (u, h) exists, with $u(t, r) > 0$ and $h'(t) > 0$ for $t > 0$ and $0 \leq r < h(t)$, and a spreading-vanishing dichotomy holds, namely, a spatial barrier $r = R^*$ exists, such that either

- **Spreading:** the free boundary breaks the barrier at some finite time (i.e., $h(t_0) \geq R^*$ for some $t_0 \geq 0$), and then the free boundary goes to infinity as $t \rightarrow \infty$ (i.e., $\lim_{t \rightarrow \infty} h(t) = \infty$), and the population spreads to the entire space and stabilizes at its positive steady-state, or
- **Vanishing:** the free boundary never breaks the barrier ($h(t) < R^*$ for all $t > 0$), and the population vanishes ($\lim_{t \rightarrow \infty} u(t, r) = 0$).

Moreover, when spreading occurs, it follows from Theorem 3.6 of [7] that

$$\liminf_{t \rightarrow \infty} \frac{h(t)}{t} \geq k_*, \quad \limsup_{t \rightarrow \infty} \frac{h(t)}{t} \leq k^*$$

for some positive constants k_* and k^* determined by the pairs $(\alpha_\infty, \beta^\infty)$ and $(\alpha^\infty, \beta_\infty)$, respectively, where

$$\begin{aligned} \alpha_\infty &:= \liminf_{r \rightarrow \infty} \alpha(r), & \beta^\infty &:= \limsup_{r \rightarrow \infty} \beta(r), \\ \alpha^\infty &:= \limsup_{r \rightarrow \infty} \alpha(r), & \beta_\infty &:= \liminf_{r \rightarrow \infty} \beta(r). \end{aligned}$$

It follows that if both $\lim_{r \rightarrow \infty} \alpha(r)$ and $\lim_{r \rightarrow \infty} \beta(r)$ exist, then $\lim_{t \rightarrow \infty} \frac{h(t)}{t} = k$ exists, and one may regard k as the asymptotic spreading speed.

The main purpose of this paper is to show that under condition (1.2), $\lim_{t \rightarrow \infty} \frac{h(t)}{t}$ also exists, and we will use pulsating semi-waves (to be defined below) induced by (1.1) to determine this limit. These semi-waves are solutions of the one-dimensional problem

$$\begin{cases} u_t - du_{xx} = u[a(x) - b(x)u], & t \in \mathbb{R}, \quad -\infty < x < h(t), \\ u(t, h(t)) = 0, \quad h'(t) = -\mu u_x(t, h(t)), & t \in \mathbb{R}. \end{cases} \tag{1.3}$$

Asymptotic spreading in spatially periodic environment based on Cauchy problem models has received extensive study recently. The spreading speed in such models is usually determined by the so called pulsating fronts, whose existence, uniqueness and other properties have been investigated by many authors; see [1–5, 12, 14, 16, 22] and the references therein for more details. In particular, a pulsating front of the reaction diffusion equation

$$u_t - du_{xx} = u[a(x) - b(x)u], \quad (t, x) \in \mathbb{R}^2, \tag{1.4}$$

is a solution to this equation of the form $u(t, x) = \Psi(x - ct, x)$, where c (the speed) is a positive constant and the function $\Psi(\xi, x)$ (the profile) is L -periodic in x ; moreover, $\lim_{t \rightarrow -\infty} u(t, x) = 0$, $\lim_{t \rightarrow +\infty} u(t, x)$ is the unique

positive steady state of (1.4). It can be shown that $u(t, x)$ is strictly increasing in t . Let us also observe that $u(t + \frac{L}{c}, x) = u(t, x - L)$.

By a well-known result of Berestycki, Hamel and Roques [5], there is a minimal speed $c_* > 0$ such that for each $c \geq c_*$, (1.4) has a pulsating front with average speed c , and no pulsating front exists with average speed $c < c_*$. Moreover, it is well known (see [2,13,22]) that this minimal average speed c_* is the spreading speed for the Cauchy problem

$$v_t - dv_{xx} = v[a(x) - b(x)v], \quad x \in \mathbb{R}, t > 0; \quad v(0, x) = v_0(x), \quad x \in \mathbb{R},$$

where the initial function $v_0(x)$ is nonnegative with nonempty compact support.

In contrast to (1.4), we will show that there is only one average speed $C = C(\mu)$ for which (1.3) has a pulsating semi-wave, and such a semi-wave is unique up to translations in t (see Theorem 1.2). Moreover, as mentioned above, this average speed is the spreading speed for the free boundary model (1.1) when spreading happens (Theorem 1.3). Furthermore, we will show that as $\mu \rightarrow \infty$, $C(\mu)$ increases to c_* (Theorem 4.2).

We now describe our results more precisely. Our definition below for pulsating semi-waves to (1.3) is motivated by the notion of pulsating fronts, and ideas in [18,21].

Definition 1.1. We call $(u(t, x), h(t))$ a **pulsating semi-wave** of (1.3) if it solves (1.3) and

- (i) $u(t, x) = U(h(t), h(t) - x) > 0$ for $t \in \mathbb{R}, x < h(t)$,
- (ii) there exists $T > 0$ such that $h'(t)$ is a positive T -periodic function and $h(t + T) - h(t) = L$,
- (iii) $U(\tau, \xi) \in C^{1,2}(\mathbb{R} \times [0, +\infty))$ is L -periodic in τ .

It will become clear below that $C := L/T$ is the (average) speed of the semi-wave. Let us also observe that $u(t + T, x) = u(t, x - L)$.

Theorem 1.2. *Problem (1.3) always has a pulsating semi-wave (\tilde{u}, \tilde{h}) . The pulsating semi-wave is unique up to translations in t . Furthermore, $\lim_{t \rightarrow \pm\infty} \tilde{h}(t)/t = L/T$, $\tilde{u}_t(t, x) > 0$, and $\tilde{u}(t, x) \rightarrow \phi(x)$ as $t \rightarrow +\infty$ uniformly in any interval of the form $(-\infty, M]$, $M \in \mathbb{R}$, where ϕ is the unique positive solution of*

$$-d\phi_{xx} = \phi[a(x) - b(x)\phi], \quad x \in \mathbb{R}^1.$$

Note that the existence and uniqueness of ϕ is a consequence of Theorem 2.3 of [11]; more general results can be found in [4,20]. Using Theorem 1.2, we can deduce the following result on the asymptotic spreading speed determined by (1.1).

Theorem 1.3. *Suppose that (1.2) holds, (u, h) is the unique solution of (1.1) and $\lim_{t \rightarrow \infty} h(t) = \infty$; then*

$$\lim_{t \rightarrow \infty} \frac{h(t)}{t} = L/T, \quad \text{where } L/T \text{ is the average speed of the semi-wave in Theorem 1.2.}$$

We remark that Theorem 1.3 only gives the asymptotic speed of the free boundary $|x| = h(t)$. However, from its proof, one sees that for any $\sigma \in (0, \underline{a}/\bar{b})$, where $\underline{a} = \min_r a(r)$ and $\bar{a} = \max_r b(r)$, the set $\{x: u(x, t) > \sigma\}$ expands to \mathbb{R}^N with asymptotic speed L/T . Therefore this agrees with the spreading speed in the usual sense.

The existence part of Theorem 1.2 will be proved in Section 2, while Section 3 is devoted to the proof of the rest of Theorem 1.2 as well as some further basic properties of the pulsating semi-wave. The proof of Theorem 1.3 is given in Section 4, where we also show that the spreading speed L/T increases strictly in μ , and as $\mu \rightarrow \infty$, the spreading speed converges to c_* , which is the minimal speed of the pulsating fronts to (1.4).

This paper is a sequel to [9], where the time-periodic case of the free boundary problem was considered. It turns out that very different techniques have to be used to handle the space-periodic case, though some ideas in the time-periodic case can be borrowed. Similarly to the approach in [9], we prove the existence of a pulsating semi-wave via a fixed point argument. However, the techniques here are completely new. The proof for uniqueness of the pulsating semi-wave is based on ideas introduced in [9], with considerable changes in the arguments. In [23], independently, (1.3) and its corresponding initial value problem are investigated by a completely different method, which is based on the approach developed in [12].

Our analysis in this paper carries over easily when the logistic nonlinearity $u[\alpha(r) - \beta(r)u]$ is replaced by a more general Fisher–KPP type function $f(r, u)$, which is smooth and satisfies

- (i) $f(r, 0) \equiv 0, f(r, q(r)) \equiv 0$, where $q(r)$ is bounded from above and below by positive constants,
- (ii) $\lim_{r \rightarrow \infty} [f(r, u) - g(r, u)] = 0$ locally uniformly in $u \in [0, \infty)$, with g periodic in r ,
- (iii) $f(r, u)/u$ is strictly decreasing in u , for every $r \geq 0$.

With care, one could further extend the results to the case that $d\Delta u$ is replaced by $\text{div}(d(|x|)\nabla u)$, and μ is replaced by $\mu(r)$, with suitable conditions on $d(r)$ and $\mu(r)$.

2. Existence of pulsating semi-waves

We use $C^v_L(\mathbb{R})$ to denote the set of all L -periodic C^v functions and suppose that $p, a, b \in C^v_L(\mathbb{R})$ for some $v \in (0, 1)$, with both a and b positive. In order to prove the existence of a pulsating semi-wave, we consider the following problem

$$\begin{cases} p(\tau)(U_\tau + U_\xi) - dU_{\xi\xi} = U[a(\tau - \xi) - b(\tau - \xi)U], & (\tau, \xi) \in \mathbb{R} \times (0, \infty), \\ U(\tau, 0) = 0, & \tau \in \mathbb{R}. \end{cases} \tag{2.1}$$

The relationship between (2.1) and (1.3) is given in the following result.

Proposition 2.1. *If (2.1) has a positive solution $U(\tau, \xi)$ which is L -periodic in τ , and satisfies $\mu U_\xi(\tau, 0) \equiv p(\tau) > 0$ for $\tau \in \mathbb{R}$, then $(u(t, x), h(t))$ given by*

$$u(t, x) = U(h(t), h(t) - x), \quad t = \int_0^{h(t)} \frac{1}{p(\tau)} d\tau \tag{2.2}$$

is a pulsating semi-wave to (1.3).

Proof. Clearly

$$1 = h'(t) \frac{1}{p(h(t))}, \quad \text{i.e.,} \quad h'(t) = p(h(t)).$$

We calculate to obtain

$$\begin{aligned} u_t - du_{xx} &= h'(t)(U_\tau + U_\xi) - dU_{\xi\xi} \\ &= p(h(t))[U_\tau(h(t), h(t) - x) + U_\xi(h(t), h(t) - x)] - dU_{\xi\xi} \\ &= U[a(x) - b(x)U] \\ &= u[a(x) - b(x)u], \end{aligned}$$

and

$$h'(t) = p(h(t)) = \mu U_\xi(h(t), 0) = -\mu u_x(t, h(t)).$$

It is evident that $u(t, h(t)) = U(h(t), 0) = 0$.

It remains to show that $h'(t)$ is T -periodic for some $T > 0$ and $h(T) - h(0) = L$. We prove that $h'(t)$ is T -periodic with

$$T := \int_0^L \frac{ds}{p(s)}.$$

Indeed, from

$$t = \int_0^{h(t)} \frac{ds}{p(s)} \quad \text{and} \quad t + T = \int_0^{h(t+T)} \frac{ds}{p(s)}$$

we obtain

$$T = \int_{h(t)}^{h(t+T)} \frac{ds}{p(s)}.$$

Since $p(\tau)$ is L -periodic and positive, we have

$$T = \int_0^L \frac{ds}{p(s)} = \int_{h(t)}^{h(t)+L} \frac{ds}{p(s)}.$$

Hence

$$\int_{h(t)}^{h(t+T)} \frac{ds}{p(s)} = \int_{h(t)}^{h(t)+L} \frac{ds}{p(s)},$$

which implies that

$$h(t + T) = h(t) + L, \quad h'(t + T) = h'(t).$$

Thus $(u(t, x), h(t))$ is indeed a pulsating semi-wave of (1.3). \square

Let us note that the pulsating semi-wave given by (2.2) satisfies $h(0) = 0$. It is easily seen that for any fixed $t_0 \in \mathbb{R}$, $(u(t + t_0, x), h(t + t_0))$ is also a pulsating semi-wave to (1.3). It will be shown that the pulsating semi-wave is unique subject to this kind of time shifts.

To prove the existence of a function pair $(p(\tau), U(\tau, \xi))$ such that (2.1) holds and $p(\tau) = \mu U_\xi(\tau, 0)$, we break the argument into two major steps. In step one, we show that for any given positive $p \in C_L^v(\mathbb{R})$, (2.1) has a unique maximal nonnegative solution U^p which is L -periodic in τ . This defines a mapping $T : p \rightarrow \mu U_\xi^p(\cdot, 0)$. In the second step, we show that T has a fixed point p^* , and thus obtain the required solution pair (p^*, U^{p^*}) .

In order to apply suitable fixed point theorems to the operator T , it is convenient to consider nonnegative p , but $h(t)$ is not well defined for such p . To avoid this difficulty, we use a perturbation approach. For small $\epsilon > 0$, we replace the original problem (2.1) by

$$\begin{cases} p_\epsilon(\tau)(U_\tau + U_\xi) - dU_{\xi\xi} = U[a(\tau - \xi) - b(\tau - \xi)U], & (\tau, \xi) \in \mathbb{R} \times (0, +\infty), \\ U(\tau, 0) = 0, & \tau \in \mathbb{R}, \end{cases} \tag{2.3}$$

where

$$p_\epsilon(\tau) = \max\{p(\tau), \epsilon\}.$$

We will show that (2.3) has a unique maximal nonnegative solution $U^{p,\epsilon}(\tau, \xi)$ that is L -periodic in τ , and the operator $T^\epsilon : p \rightarrow \mu U_\xi^{p,\epsilon}(\cdot, 0)$ has a fixed point p^ϵ . Moreover, we will show that there exists $\delta > 0$ such that $p^\epsilon \geq \delta$ for all small ϵ . Hence $(p^\epsilon, U^{p^\epsilon,\epsilon})$ solves the original unperturbed problem when $\epsilon \in (0, \delta]$, and $U^{p^\epsilon,\epsilon}$ is a positive solution.

2.1. Existence of $U^{p,\epsilon}$

In this subsection we show that for any $p \in C_L^v(\mathbb{R})$ and $\epsilon > 0$, (2.3) has a maximal nonnegative solution $U^{p,\epsilon}$. We also determine exactly when this solution is positive. To this end, we need the following eigenvalue problem

$$\begin{cases} \mathcal{L}_\epsilon U = \lambda a(\tau - \xi)U, & (\tau, \xi) \in \mathbb{R}^2, \\ \text{where } \mathcal{L}_\epsilon U = p_\epsilon(\tau)(U_\tau + U_\xi) - dU_{\xi\xi}. \end{cases} \tag{2.4}$$

Proposition 2.2. *The following conclusions hold:*

(1) For any nonnegative $p \in C^v_L(\mathbb{R})$, and $\epsilon > 0$, $\alpha \in \mathbb{R}$, there exists a unique $\lambda(\alpha, p, \epsilon) \in \mathbb{R}$ with corresponding positive function $\phi_{\alpha,p,\epsilon} = \phi_{\alpha,p,\epsilon}(\tau, \xi) \in C^{1,2}(\mathbb{R} \times \mathbb{R})$, which is L -periodic both in τ and ξ , such that $(\lambda, U) = (\lambda(\alpha, p, \epsilon), e^{\alpha\xi}\phi_{\alpha,p,\epsilon})$ satisfies (2.4).

(2) Let

$$\lambda_1(p, \epsilon) = \sup\{\lambda \in \mathbb{R}: \exists \phi \in C^{1,2}(\mathbb{R} \times \mathbb{R}), \phi(\tau, \xi) \text{ is positive and } L\text{-periodic in } \tau, \text{ and } \mathcal{L}_\epsilon \phi \geq \lambda a(\tau - \xi)\phi\}.$$

Then there is a unique $\alpha_0 \in \mathbb{R}$ such that $\lambda_1(p, \epsilon) = \lambda(\alpha_0, p, \epsilon)$. Moreover, $\alpha_0 > 0$.

(3) Suppose $\lambda = \tilde{\lambda}(l, p, \epsilon)$ is the principal eigenvalue of the eigenvalue problem

$$\begin{cases} \mathcal{L}_\epsilon U = \lambda a(\tau - \xi)U, & (\tau, \xi) \in \mathbb{R} \times (0, l), \\ U(\tau, \xi) = U(\tau + L, \xi), & U(\tau, 0) = U(\tau, l) = 0. \end{cases} \tag{2.5}$$

Then $\tilde{\lambda}(l, p, \epsilon)$ decreases to $\lambda_1(p, \epsilon)$ as $l \rightarrow +\infty$.

(4) $\tilde{\lambda}(l, p, \epsilon)$ is continuous in (l, p, ϵ) and $\lambda(\alpha, p, \epsilon)$ is continuous in (α, p, ϵ) , where $l, \epsilon > 0$, $\alpha \in \mathbb{R}$ and $p \in C^v_L(\mathbb{R})$.

(5) $\lambda(\alpha, p, \epsilon)$ is concave in α .

Proof. All the conclusions here follow from the main results of [19], except that we need to prove that $\alpha_0 > 0$ in conclusion (2). By conclusions (4) and (5), $\lambda(\alpha, p, \epsilon)$ is continuous and concave in α . Moreover, it is obvious that $\lambda(0, p, \epsilon) = 0$ (with corresponding $\phi_{0,p,\epsilon}$ a positive constant). Hence, we only need to prove that there is some $\alpha' > 0$ such that $\lambda(\alpha', p, \epsilon) = 0$. To show this, due to the uniqueness of the principal eigenvalue proved in [19], it suffices to find a positive function $\phi_0(\tau, \xi)$ which is L -periodic in τ , and a positive number α' , such that $U_0 := e^{\alpha'\xi}\phi_0(\tau, \xi)$ satisfies $\mathcal{L}_\epsilon U_0 = 0$. We now look for such a function ϕ_0 of the special form $\phi_0(\tau, \xi) = \psi(\tau)$. Then $\mathcal{L}_\epsilon U_0 = 0$ reduces to

$$\{p_\epsilon(\tau)\psi'(\tau) + [p_\epsilon(\tau)\alpha' - d(\alpha')^2]\psi(\tau)\}e^{\alpha'\xi} = 0.$$

Hence

$$\psi' = \alpha' \left[\frac{d}{p_\epsilon(\tau)}\alpha' - 1 \right] \psi.$$

Since $\psi(\tau)$ is L -periodic, we have

$$\alpha' \int_0^L \frac{d}{p_\epsilon(\tau)} d\tau = L,$$

which implies $\alpha' > 0$. Clearly

$$\psi(\tau) = \exp \int \alpha' \left[\frac{d\alpha'}{p_\epsilon(\tau)} - 1 \right] d\tau > 0.$$

This completes our proof. \square

We also need the following auxiliary logistic problem

$$p_\epsilon(\tau)(U_\tau + U_\xi) - dU_{\xi\xi} = U[a(\tau - \xi) - b(\tau - \xi)U], \quad (\tau, \xi) \in \mathbb{R}^2. \tag{2.6}$$

The following result is contained in [20].

Proposition 2.3. Problem (2.6) has a positive solution $\bar{U}^{p,\epsilon} = \bar{U}^{p,\epsilon}(\tau, \xi)$ which is L -periodic both in τ and ξ if and only if $\lambda(0, p, \epsilon) < 1$. Moreover, for any nonnegative L -periodic continuous initial function $\psi = \psi(\xi) \not\equiv 0$, the solution of (2.6) with $U(0, \xi) = \psi(\xi)$, denoted by $U(\tau, \xi, \psi)$, satisfies $\lim_{\tau \rightarrow +\infty} |U(\tau, \xi, \psi) - \bar{U}^{p,\epsilon}(\tau, \xi)| = 0$ uniformly for $\xi \in \mathbb{R}$.

Remark 2.4. If $p(\tau) \geq \epsilon$ for $\tau \in \mathbb{R}$, then by the transformation in Proposition 2.1, $u(t, x) = \bar{U}^{p,\epsilon}(h(t), h(t) - x)$ is a positive entire solution of (1.4), which is L -periodic in x and $\int_0^L 1/p(\tau) d\tau$ -periodic in t . Hence it must coincide with $\phi(x)$, the unique positive periodic solution of $-du_{xx} = u[a(x) - b(x)u]$, $x \in \mathbb{R}$.

Now, we are ready to show the main result of this subsection.

Proposition 2.5. *The following conclusions hold:*

- (1) *For any fixed $p \in C_L^v(\mathbb{R})$ and any positive constant ϵ , problem (2.3) admits a maximal nonnegative L -periodic in τ solution $U^{p,\epsilon} = \bar{U}^{p,\epsilon}(\tau, \xi)$ in the sense that any other nonnegative L -periodic in τ solution is bounded from above by $U^{p,\epsilon}$. Furthermore, $U^{p,\epsilon} \equiv 0$ if and only if $\lambda_1(p, \epsilon) \geq 1$.*
- (2) *For any $p \in C_L^v(\mathbb{R})$ and $\epsilon > 0$ with $\lambda_1(p, \epsilon) < 1$, $U^{p,\epsilon}$ is the unique positive L -periodic in τ solution of (2.3). Moreover, $\lim_{\xi \rightarrow +\infty} |U^{p,\epsilon}(\tau, \xi) - \bar{U}^{p,\epsilon}(\tau, \xi)| = 0$ uniformly for $\tau \in \mathbb{R}$.*

Proof. First, we make use of some simple facts whose easy proof can be found in Step 1 of the proof of Proposition 2.1 in [9]. Suppose that u^l is the unique positive solution of

$$\begin{cases} -du_{\xi\xi} = u(\bar{a} - \underline{b}u) & \text{in } (0, \ell), \\ u(0) = 0, \quad u(\ell) = \infty, \end{cases} \tag{2.7}$$

where

$$\bar{a} = \max_r a(r), \quad \underline{b} = \min_r b(r),$$

and u^∞ is the limit of u^l as $l \rightarrow +\infty$. Then $u^\infty = u^\infty(\xi) \leq \max a / \min b$, and for every constant $M \geq 1$, Mu^∞ is a supersolution of (2.3). By a sweeping argument, any L -periodic in τ solution of (2.3) is bounded from above by $\sup u^\infty$.

Let us now prove conclusion (1). When $\lambda_1(p, \epsilon) \geq 1$, by Proposition 2.2, there is some $\alpha_0 > 0$ such that $\lambda_1(p, \epsilon) = \lambda(\alpha_0, p, \epsilon)$. It is easily seen that the corresponding function $e^{\alpha_0\xi} \phi_{\alpha_0, p, \epsilon}$ and its product with any positive constant are L -periodic in τ supersolutions of (2.3). Suppose that (2.3) has a positive L -periodic in τ solution U . Then by the boundedness of U , we can suppose that $Me^{\alpha_0\xi} \phi_{\alpha_0, p, \epsilon}(\tau, \xi) \geq U(\tau, \xi)$ on $\mathbb{R} \times [0, +\infty)$. We may assume that $M > 0$ is the minimal constant such that the above inequality holds. Since $\alpha_0 > 0$, the equality must hold at some (τ_0, ξ_0) in the above inequality. But the strong maximum principle shows that it is impossible. Hence the maximal nonnegative L -periodic solution $U^{p,\epsilon}$ is identically 0 when $\lambda_1(p, \epsilon) \geq 1$.

In the remaining case $\lambda_1(p, \epsilon) < 1$, by Proposition 2.2, there is some large l such that $\tilde{\lambda}(l, p, \epsilon) < 1$. Suppose that $\tilde{\phi}_{l, p, \epsilon} > 0$ is the corresponding eigenfunction of (2.5) normalized by $\max \tilde{\phi}_{l, p, \epsilon} = 1$. Then for any sufficiently small constant γ ,

$$\psi(\tau, \xi) = \begin{cases} \gamma \tilde{\phi}_{l, p, \epsilon}(\tau, \xi - l), & \tau \in \mathbb{R}, \xi \in [l, 2l], \\ 0, & \tau \in \mathbb{R}, \xi \in \mathbb{R} \setminus [l, 2l] \end{cases}$$

is a subsolution of (2.3). Therefore, we can find a maximal positive L -periodic in τ solution $U^{p,\epsilon}$ in the order interval $[\psi, u^\infty]$. Since any positive solution of (2.3) is bounded from above by u^∞ , $U^{p,\epsilon}$ is the maximal positive solution.

Finally we prove conclusion (2). Let $\psi(\tau, \xi)$ be defined as above, with $l = kL$ for some large positive integer k , so that it is an L -periodic in τ subsolution of (2.3) for small γ . For each nonnegative integer i we define

$$\psi_i(\tau, \xi) = \psi(\tau, \xi - ikL).$$

It is easily seen that ψ_i is a subsolution of (2.3). Let $U = U(\tau, \xi)$ be a positive L -periodic in τ solution of (2.3). For each $i \geq 0$, there exists $\sigma_i \in (0, 1)$ such that $U(\tau, \xi) > \sigma_i \psi_i(\tau, \xi)$ for $\tau \in \mathbb{R}$ and $\xi \geq 0$. For any $\sigma \in [\sigma_i, 1]$, $\sigma \psi_i$ is a subsolution of (2.3). We claim that $U(\tau, \xi) > \sigma \psi_i(\tau, \xi)$ for all $\tau \in \mathbb{R}$, $\xi \geq 0$ and $\sigma \in [\sigma_i, 1]$. Otherwise, there exists $\sigma_* \in (\sigma_i, 1]$ and $(\tau_*, \xi_*) \in (0, L] \times ((i + 1)kL, (i + 2)kL)$ such that

$$U(\tau, \xi) \geq \sigma_* \psi_i(\tau, \xi) \quad \text{for } \tau \in \mathbb{R}, \xi \geq 0; \quad U(\tau_*, \xi_*) = \sigma_* \psi_i(\tau_*, \xi_*).$$

We may then apply the strong maximum principle to conclude that $U \equiv \sigma_* \psi_i$, a contradiction. This proves the claim, which implies in particular,

$$U(\tau, \xi) > \psi_i(\tau, \xi) \quad \text{for } \tau \in \mathbb{R}, \xi \geq 0. \tag{2.8}$$

Let $\{\xi_i\}$ be an arbitrary sequence increasing to $+\infty$ as $i \rightarrow +\infty$, and define $U_i(\tau, \xi) = U(\tau, \xi + \xi_i)$. By applying standard L^p theory (see [17]) to the equation satisfied by U_i and Sobolev embedding (see Lemma 3.3 in [15]), one sees

that by passing to a subsequence, $U_i \rightarrow \check{U}$ as $i \rightarrow \infty$ locally uniformly in \mathbb{R}^2 , and \check{U} is L -periodic in τ . Moreover, if we write $\xi_i = n_i L + \tilde{\xi}_i$ with $\tilde{\xi}_i \in [0, L)$, and assume that $\tilde{\xi}_i \rightarrow \tilde{\xi}_0$, then $\check{U}(\tau, \xi - \tilde{\xi}_0)$ solves (2.6). Furthermore, due to (2.8), we always have $\sup_{(\tau, \xi) \in \mathbb{R}^2} \check{U}(\tau, \xi - \tilde{\xi}_0) \geq \gamma$. Therefore, $\check{U}(\tau, \xi - \tilde{\xi}_0)$ is a positive L -periodic in τ solution of (2.6). Hence $\check{U}(\tau, \xi - \tilde{\xi}_0) \equiv \overline{U}^{p, \epsilon}(\tau, \xi)$. Clearly the above discussion implies that $\lim_{\xi \rightarrow +\infty} |U(\tau, \xi) - \overline{U}^{p, \epsilon}(\tau, \xi)| = 0$ uniformly for $\tau \in \mathbb{R}$.

It remains to show the uniqueness of U . We follow a standard argument. If there is another positive L -periodic in τ solution $\tilde{U} \not\equiv U$, then from the conclusion proved above, we have

$$\lim_{\xi \rightarrow +\infty} \frac{U(\tau, \xi)}{\tilde{U}(\tau, \xi)} = 1 \quad \text{uniformly in } \tau \in \mathbb{R}. \tag{2.9}$$

Moreover, by the Hopf boundary lemma, $U_\xi(\tau, 0)$ and $\tilde{U}_\xi(\tau, 0)$ are bounded away from 0 and ∞ for all $\tau \in \mathbb{R}$. Therefore there is some $M \in (0, 1)$ such that $\tilde{U}(\tau, \xi) \geq MU(\tau, \xi)$ on $\mathbb{R} \times [0, +\infty)$, and we may assume that M takes the maximal value such that this inequality holds (we may interchange U and \tilde{U} to guarantee $M < 1$). Due to (2.9), either $\tilde{U}(\tau_0, \xi_0) = MU(\tau_0, \xi_0)$ at some $\tau_0 \in \mathbb{R}, \xi_0 \in (0, +\infty)$ or $\frac{\partial \tilde{U}}{\partial \xi}(\tau_0, 0) = M \frac{\partial U}{\partial \xi}(\tau_0, 0)$, and the strong maximum principle then implies $\tilde{U} \equiv MU$. But $M < 1$ implies that MU is not a solution of (2.3). This contradiction completes our proof. \square

We may now define the mapping T^ϵ on $C_L^v(\mathbb{R})$ by $T^\epsilon(p) = \mu U_\xi^{p, \epsilon}(\cdot, 0)$.

2.2. T^ϵ has a fixed point

We are going to use Schauder’s fixed point theorem to conclude that T^ϵ has a fixed point.

Lemma 2.6. T^ϵ is completely continuous on $C_L^v(\mathbb{R})$.

Proof. First, we show that for any positive $\delta \in (0, 1)$, the norm of $U_\xi^{p, \epsilon}(\cdot, 0)$ in $C_L^\delta(\mathbb{R})$ can be controlled by $\|p\|_{C_L^0(\mathbb{R})}$ when all other parameters are fixed.

Set

$$s = f(\tau) := \int_0^\tau \beta_\epsilon(t) dt, \quad V(s, \xi) := U^{p, \epsilon}(f^{-1}(s), \xi)$$

where $\beta_\epsilon(t) = \frac{1}{p_\epsilon(t)}$. Then $V(s, \xi)$ is periodic in s with period $\int_0^L \beta_\epsilon(t) dt$, and is a positive solution of

$$\begin{cases} V_s + p_\epsilon(f^{-1}(s))V_\xi - dV_{\xi\xi} = V[a(f^{-1}(s) - \xi) - b(f^{-1}(s) - \xi)V], & s \in \mathbb{R}, \xi > 0, \\ V(s, 0) = 0, & s \in \mathbb{R}. \end{cases} \tag{2.10}$$

Since $0 \leq V \leq u^\infty \leq \max a / \min b$, we can apply the L^p estimates (see, for example, Theorem 7.15 of [17]) to (2.10) to conclude that $\|V(s_0 + \cdot, \cdot)\|_{W_q^{1,2}([0,1] \times [0,l])} \leq C$ for all $s_0 \in \mathbb{R}, q > 1, l > 0$ and some constant C depending only on $\|p\|_{C_L^0(\mathbb{R})}, l$ and q . By Sobolev embedding (see, e.g. Lemma 3.3 of [15]), we obtain, for every $\delta \in (0, 1)$,

$$\|V(s_0 + \cdot, \cdot)\|_{C^{\frac{1+\delta}{2}, 1+\delta}([0,1] \times [0,l])} \leq C_{\delta,l} \quad \forall s_0 \in \mathbb{R}.$$

Therefore, we have

$$\begin{aligned} \frac{|U_\xi^{p, \epsilon}(t_1, 0) - U_\xi^{p, \epsilon}(t_2, 0)|}{|t_1 - t_2|^\delta} &= \frac{|V_\xi(f(t_1), 0) - V_\xi(f(t_2), 0)|}{|f(t_1) - f(t_2)|^\delta} \cdot \frac{|f(t_1) - f(t_2)|^\delta}{|t_1 - t_2|^\delta} \\ &\leq C |\beta_\epsilon(\cdot)|_{C_L^0(\mathbb{R})}^\delta \leq C \epsilon^{-\delta}. \end{aligned}$$

This implies that, for any $M > 0, \{U_\xi^{p, \epsilon}(\cdot, 0) : \|p\|_{C_L^v(\mathbb{R})} \leq M\}$ is bounded in $C_L^\delta(\mathbb{R})$ for some $\delta \in (v, 1)$, and hence it is pre-compact in $C_L^v(\mathbb{R})$. This proves that T^ϵ maps any bounded set of $C_L^v(\mathbb{R})$ into a pre-compact set in this space.

Moreover, if $p_n \rightarrow p_0$ in $C_L^v(\mathbb{R})$, then by compactness, by passing to a subsequence, $U^{p_n, \epsilon}(t, x) \rightarrow \tilde{U}^{p_0, \epsilon}(t, x)$ in $C_{loc}^{\frac{1+\nu}{2}, 1+\nu}(\mathbb{R} \times [0, +\infty))$, where $\tilde{U}^{p_0, \epsilon}$ is some nonnegative L -periodic in τ solution of (2.3) with $p = p_0$. It follows that $U_\xi^{p_n, \epsilon}(\cdot, 0) \rightarrow \tilde{U}_\xi^{p_0, \epsilon}(\cdot, 0)$ in $C_L^v(\mathbb{R})$. What we need to show is that $\tilde{U}^{p_0, \epsilon}$ is just $U^{p_0, \epsilon}$. If $\lambda_1(p_0, \epsilon) \geq 1$, then 0 is the unique nonnegative L -periodic in τ solution of (2.3), and our conclusion holds. If $\lambda_1(p_0, \epsilon) < 1$, we can find a sufficiently small constant γ independent of p_n such that

$$\psi^n(\tau, \xi) = \begin{cases} \gamma \tilde{\phi}_{l, p_n, \epsilon}(\tau, \xi), & \tau \in \mathbb{R}, \xi \in [0, l], \\ 0, & \tau \in \mathbb{R}, \xi \in (l, +\infty) \end{cases}$$

is a subsolution of (2.3) with $p = p_n$, where $\|\tilde{\phi}_{l, p_n, \epsilon}\|_{C^0(\mathbb{R} \times [0, l])} = 1$. It follows that $U^{p_n, \epsilon} \geq \psi^n$ and hence $\|U^{p_n, \epsilon}\|_{C^0(\mathbb{R} \times [0, +\infty))} \geq \gamma > 0$, which infers $\|\tilde{U}^{p_0, \epsilon}\|_{C^0(\mathbb{R} \times [0, +\infty))} > 0$. Thus $\tilde{U}^{p_0, \epsilon} \equiv U^{p_0, \epsilon}$. This shows that T^ϵ is continuous. \square

In order to use Schauder’s fixed point theorem to prove the existence of a fixed point of T^ϵ , we look for an invariant set of T^ϵ which is bounded, closed and convex. In the proof of Proposition 2.5, we have shown that $U^{p, \epsilon}(\tau, \xi) \leq u^\infty(\xi)$ on $\mathbb{R} \times [0, +\infty)$ for any $p \in C_L^v(\mathbb{R})$. We note that $U^{p, \epsilon}(\tau, 0) = u^\infty(0) = 0$.

Lemma 2.7. *There exists $M = M_\epsilon > 0$ such that $E_\epsilon := \{p \in C_L^v(\mathbb{R}) : \|p\|_{C_L^v(\mathbb{R})} \leq M, 0 \leq p(\tau) \leq \mu(u^\infty)'(0) \forall \tau \in \mathbb{R}\}$ is an invariant set of T^ϵ .*

Proof. First, for any $p \in C_L^v(\mathbb{R})$, $0 \leq U_\xi^{p, \epsilon}(\tau, 0) \leq (u^\infty)'(0)$. Moreover, for $p(\cdot) \in \tilde{E} := \{p \in C_L^v(\mathbb{R}) : 0 \leq p(\tau) \leq \mu(u^\infty)'(0) \forall \tau \in \mathbb{R}\}$, $\|p\|_\infty \leq \mu(u^\infty)'(0)$, and from (2.3) we see, by standard L^p theory for parabolic equations (see [17]) that $\{U^{p, \epsilon}\}$ has a bound in $W_q^{1,2}([0, L] \times [0, 1])$ ($\forall q > 1$) that is independent of $p \in \tilde{E}$. By Sobolev embedding we know that $\{U^{p, \epsilon}\}$ has a bound in $C^{\frac{1+\nu}{2}, 1+\nu}([0, L] \times [0, 1])$ ($\nu \in (0, 1)$) that is independent of $p \in \tilde{E}$. Therefore $\{U_\xi^{p, \epsilon}(\cdot, 0) : p \in \tilde{E}\}$ is bounded in $C_L^v(\mathbb{R})$, say $\|U_\xi^{p, \epsilon}(\cdot, 0)\|_{C_L^v(\mathbb{R})} \leq M_\epsilon$ for all $p \in \tilde{E}$. Define $E_\epsilon := \{p \in \tilde{E} : \|p\|_{C_L^v(\mathbb{R})} \leq M_\epsilon\}$. Then clearly E_ϵ is invariant under T^ϵ . \square

Thus by Schauder’s fixed point theorem we obtain

Proposition 2.8. *For any $\epsilon > 0$, T^ϵ has a fixed point \bar{p}^ϵ in E_ϵ .*

2.3. $\bar{p}^\epsilon(\tau) \geq \epsilon$ for all small $\epsilon > 0$

Proposition 2.9. *There is some $\epsilon_0 > 0$ such that $\bar{p}^{\epsilon_0}(\tau) > \epsilon_0$ on \mathbb{R} and hence for $p = \bar{p}^{\epsilon_0}$, (2.1) has a positive L -periodic in τ solution $U^{\bar{p}^{\epsilon_0}, \epsilon_0}$ such that $\bar{p}^{\epsilon_0}(\tau) = \mu U_\xi^{\bar{p}^{\epsilon_0}, \epsilon_0}(\tau, 0)$.*

Proof. We only need to show that $\liminf_{\epsilon \rightarrow 0} \min_{\tau \in \mathbb{R}} \bar{p}^\epsilon(\tau) > 0$. We use two steps to prove this conclusion.

Step 1. We show that $\liminf_{\epsilon \rightarrow 0} \|\bar{p}^\epsilon\|_{C_L^0(\mathbb{R})} > 0$.

Recall that

$$\underline{a} = \min a, \quad \bar{a} = \max a, \quad \underline{b} = \min b, \quad \bar{b} = \max b.$$

First, we can find some δ_0 small and $l_0 > 0$ large such that for each $\delta \in (0, \delta_0]$ and $l \geq l_0$, the problem

$$-dU'' + \delta U' = U[\underline{a} - \bar{b}U] \quad \text{in } (0, l), \quad U(0) = U'(l) = 0$$

has a unique positive solution U_l , and U_l satisfies $U_l'(\xi) > 0$ in $[0, l)$. (The existence follows from a simple upper and lower solution argument, and the uniqueness is a consequence of the concavity of the nonlinearity. The fact that $U_l' > 0$ in $[0, l)$ follows from $U_l(\underline{a} - \bar{b}U_l) > 0$ in $[0, l)$ and $U_l'(l) = 0$.)

Define $\underline{U}(\xi) = U_l(\xi)$ in $[0, l]$ and $\underline{U}(\xi) = U_l(2l - \xi)$ for $\xi \in (l, 2l]$, and $\delta(\xi) = \delta \operatorname{sgn}(l - \xi)$. Then it is easily seen that \underline{U} is a weak solution of

$$-dU'' + \delta(\xi)U' = U(\underline{a} - \bar{b}U) \quad \text{in } (0, 2l), \quad U(0) = U(2l) = 0. \tag{2.11}$$

If $p(\tau) < \delta$ in \mathbb{R} , then clearly $p(\tau)U'(\xi) \leq \delta(\xi)U'(\xi)$ in $[0, 2l]$ for all τ . It follows easily from the comparison principle that $U^{p,\epsilon}(\tau, \xi) \geq U(\xi)$ for all $\tau \in \mathbb{R}$ and $\xi \in [0, 2l]$. Hence $U_{\xi}^{p,\epsilon}(\tau, 0) \geq U'(0)$ for all τ .

If $\liminf_{\epsilon \rightarrow 0} \|\bar{p}^{\epsilon}\|_{C^0_L(\mathbb{R})} = 0$, then we can find some $\epsilon_0 < \min\{\delta, U'(0)\}$ such that $\bar{p}^{\epsilon_0}(\tau) < \min\{\delta, \mu U'(0)\}$ for all τ . This and $U^{\bar{p}^{\epsilon_0}, \epsilon_0}(\tau, \xi) \geq U(\xi)$ on $\mathbb{R} \times [0, +\infty)$ imply that $\mu U_{\xi}^{\bar{p}^{\epsilon_0}, \epsilon_0}(\tau, 0) \geq \mu U'(0) > \bar{p}^{\epsilon_0}(\tau)$, contradicting $\bar{p}^{\epsilon_0}(\tau) = \mu U_{\xi}^{\bar{p}^{\epsilon_0}, \epsilon_0}(\tau, 0)$.

Step 2. We show that $\liminf_{\epsilon \rightarrow 0} \min_{\tau \in \mathbb{R}} \bar{p}^{\epsilon}(\tau) > 0$. Suppose by way of contradiction that this limit is 0. We are going to derive a contradiction. Since $2\theta := \liminf_{\epsilon \rightarrow 0} \|\bar{p}^{\epsilon}\|_{C^0_L(\mathbb{R})} > 0$, for every small $\epsilon > 0$, there is some $\tau_{\epsilon} \in [0, L]$ such that $\bar{p}^{\epsilon}(\tau_{\epsilon}) = \theta$. Set

$$s = f_{\epsilon}(\tau) := \int_{\tau_{\epsilon}}^{\tau} \beta_{\epsilon}(t) dt \quad \text{with } \beta_{\epsilon}(t) = \frac{1}{\max\{\bar{p}^{\epsilon}(t), \epsilon\}}.$$

It is easy to check that $f_{\epsilon}^{-1}(0) = \tau_{\epsilon}$, $\bar{p}^{\epsilon}(f_{\epsilon}^{-1}(0)) = \theta$, and if the function $g(\tau)$ is L -periodic then $g(f_{\epsilon}^{-1}(s))$ is periodic with period $S_{\epsilon} := \int_0^L \beta_{\epsilon}(t) dt$.

Denote

$$V^{\epsilon}(s, \xi) := U^{\bar{p}^{\epsilon}, \epsilon}(f_{\epsilon}^{-1}(s), \xi), \quad q^{\epsilon}(s) = \bar{p}^{\epsilon}(f_{\epsilon}^{-1}(s)),$$

and

$$\eta_1^{\epsilon}(s, \xi) = a(f_{\epsilon}^{-1}(s) - \xi), \quad \eta_2^{\epsilon}(s, \xi) = b(f_{\epsilon}^{-1}(s) - \xi).$$

Then $V^{\epsilon}(s, \xi)$ is a positive solution of

$$\begin{cases} U_s + \max\{q^{\epsilon}(s), \epsilon\}U_{\xi} - dU_{\xi\xi} = U[\eta_1^{\epsilon}(s, \xi) - \eta_2^{\epsilon}(s, \xi)U], & (s, \xi) \in \mathbb{R} \times (0, \infty), \\ U(s, 0) = 0, \quad U(s, \xi) = U(s + S_{\epsilon}, \xi), & (s, \xi) \in \mathbb{R} \times (0, \infty). \end{cases} \tag{2.12}$$

Moreover,

$$q^{\epsilon}(s) = \mu V_{\xi}^{\epsilon}(s, 0) \quad \forall s \in \mathbb{R}.$$

Let $\epsilon_n \rightarrow 0$ be such that $\min_{\tau \in \mathbb{R}} \bar{p}_{\epsilon_n}(\tau) \rightarrow 0$. Then from

$$0 \leq q^{\epsilon_n} \leq \mu(u^{\infty})'(0), \quad \underline{a} \leq \eta_1^{\epsilon_n} \leq \bar{a}, \quad \underline{b} \leq \eta_2^{\epsilon_n} \leq \bar{b}$$

we see that, by passing to a subsequence,

$$q^{\epsilon_n} \rightarrow q \quad \text{weakly in } L^2(K_1), \quad \eta_1^{\epsilon_n} \rightarrow \eta_1 \quad \text{and} \quad \eta_2^{\epsilon_n} \rightarrow \eta_2 \quad \text{weakly in } L^2(K_1 \times K_2),$$

for every compact set $K_1 \subset \mathbb{R}$ and every compact set $K_2 \subset [0, \infty)$. Clearly

$$0 \leq q \leq \mu(u^{\infty})'(0), \quad \underline{a} \leq \eta_1 \leq \bar{a}, \quad \underline{b} \leq \eta_2 \leq \bar{b}.$$

Moreover, applying L^p estimates to the equation of V^{ϵ_n} we find that $\{V^{\epsilon_n}\}$ is bounded in $W_p^{1,2}(K_1 \times K_2)$ ($\forall p > 1$) with compact sets K_1 and K_2 as described above. Therefore by Sobolev embedding we may assume, by passing to a subsequence, that $V^{\epsilon_n} \rightarrow V$ in $C_{loc}^{\frac{1+\nu}{2}, 1+\nu}(\mathbb{R} \times [0, +\infty))$ with $0 < \nu < 1$. It follows that $q^{\epsilon}(s) = \mu V_{\xi}^{\epsilon}(s, 0)$ converges to $q(s)$ in $C_{loc}^{\nu}(\mathbb{R})$ along $\epsilon = \epsilon_n$. Letting $n \rightarrow \infty$ in the equation for V^{ϵ_n} we find that V is a nonnegative weak solution of

$$\begin{cases} V_s + q(s)V_{\xi} - dV_{\xi\xi} = V[\eta_1(s, \xi) - \eta_2(s, \xi)V], & (s, \xi) \in \mathbb{R} \times (0, \infty), \\ V(s, 0) = 0, & s \in \mathbb{R}. \end{cases} \tag{2.13}$$

We also have

$$q(s) = \mu V_{\xi}(s, 0), \quad 0 \leq V(s, \xi) \leq u^{\infty}(\xi) \leq \bar{a}/\underline{b} \quad \forall s \in \mathbb{R}, \quad \forall \xi \geq 0.$$

Since $V_{\xi}^{\epsilon}(0, 0) = \bar{p}^{\epsilon}(f^{-1}(0)) = \theta$, we have $V_{\xi}(0, 0) = \theta > 0$. Therefore by the strong maximum principle V must be a positive solution. We consider the following two cases:

Case 1. $\{S_{\epsilon_n}\}$ is bounded. Without loss of the generality, suppose that $\lim_{n \rightarrow \infty} S_{\epsilon_n} = \tilde{L} < +\infty$. In this case, $q(s)$, $\eta_1(s, \xi)$, $\eta_2(s, \xi)$ and $V(s, \xi)$ are all \tilde{L} -periodic in s . Since V is a positive solution of (2.13), the Hopf lemma implies that $V_\xi(s, 0) \geq \sigma_0 > 0$ for all $s \in [0, \tilde{L}]$. Hence $V_\xi^{\epsilon_n}(s, 0) \geq \sigma_0/2$ for all $s \in \mathbb{R}$ and all large n , and thus $\tilde{p}^{\epsilon_n}(\tau) = \mu V_\xi^{\epsilon_n}(f_{\epsilon_n}(\tau), 0) \geq \mu\sigma_0/2$ for all τ and all large n , contradicting the choice of ϵ_n .

Case 2. $\{S_{\epsilon_n}\}$ is unbounded. Without loss of the generality, suppose that $\lim_{n \rightarrow \infty} S_{\epsilon_n} = +\infty$. Since

$$\int_0^{S_\epsilon} q^\epsilon(s) ds = \int_0^{S_\epsilon} \tilde{p}^\epsilon(f_\epsilon^{-1}(s)) ds \leq \int_0^{S_\epsilon} \frac{1}{\beta_\epsilon(f_\epsilon^{-1}(s))} ds \equiv L,$$

we deduce that

$$\int_0^\infty q(s) ds \leq L.$$

Applying L^p estimates to (2.13) we easily see that $\|V(s_0 + \cdot, \cdot)\|_{C^{\frac{1+\nu}{2}, 1+\nu}([0,1] \times [0,1])}$ is uniformly bounded with respect to $s_0 \in \mathbb{R}$. It follows that $0 \leq q(s) = \mu V_\xi(s, 0)$ is uniformly continuous in s . Hence from $\int_0^\infty q(s) ds < +\infty$ we can conclude that $q(s) \rightarrow 0$ as $s \rightarrow +\infty$.

Recall that \underline{U} is the unique positive solution of (2.11). Let $s_0 > 0$ be chosen such that $q(s) < \delta$ for $s \geq s_0$. Then choose $\sigma > 0$ such that $\sigma \underline{U}(\xi) \leq V(s_0, \xi)$ for $\xi \in [0, 2l]$. Since

$$q(s)\underline{U}_\xi(\xi) \leq \delta(\xi)\underline{U}_\xi(\xi) \quad \forall \xi \in [0, 2l],$$

we find that $\tilde{U} = \sigma \underline{U}$ satisfies

$$\tilde{U}_s + q(s)\tilde{U}_\xi - d\tilde{U}_{\xi\xi} \leq \tilde{U}[\eta_1(s, \xi) - \eta_2(s, \xi)\tilde{U}] \quad \forall (s, \xi) \in \mathbb{R} \times (0, \infty).$$

Clearly $\tilde{U}(0) = 0 = V(s, 0)$, $\tilde{U}(2l) = 0 < V(s, 2l)$ and $\tilde{U}(\xi) \leq V(s_0, \xi)$ for all $\xi \in (0, 2l)$. Hence we can apply the comparison principle to conclude that $V(s, \xi) \geq \tilde{U}(\xi)$ for all $s \geq s_0$ and $\xi \in [0, 2l]$. It follows that

$$V_\xi(s, 0) \geq \tilde{U}_\xi(0) > 0 \quad \forall s \geq s_0.$$

On the other hand,

$$V_\xi(s, 0) = \mu^{-1}q(s) \rightarrow 0 \quad \text{as } s \rightarrow \infty.$$

This contradiction completes our proof. \square

3. Uniqueness of the pulsating semi-wave and other basic properties

If $(u(t, x), h(t))$ is a pulsating semi-wave to (1.3), then $(U(\tau, \xi), p(\tau))$ given by

$$U(\tau, \xi) = u(h^{-1}(\tau), \tau - \xi), \quad p(\tau) = -\mu u_x(h^{-1}(\tau), \tau)$$

solves (2.1) and $p(\tau) = \mu U_\xi(\tau, 0) \in C_L^\nu(\mathbb{R})$ is positive. So

$$h'(t) = p(h(t)) \geq \min_{\tau \in \mathbb{R}} p(\tau) > 0, \quad \text{and} \quad \lim_{t \rightarrow \pm\infty} h(t) = \pm\infty.$$

Hence, due to the L -periodicity of $p(\tau)$, we have

$$\lim_{t \rightarrow \infty} \frac{h(t)}{t} = L \left(\int_0^L \frac{ds}{p(s)} \right)^{-1}.$$

Recalling that $h'(t)$ is T -periodic with $T = \int_0^L \frac{ds}{p(s)}$, we obtain

$$\lim_{t \rightarrow \infty} h(t)/t = L/T.$$

3.1. Uniqueness

To prove the uniqueness of the pulsating semi-wave, we let (u^1, h^1) and (u^2, h^2) be pulsating semi-waves of (1.3), and $(U^1, p^1), (U^2, p^2)$ be the corresponding pairs defined above. We have

$$\lim_{t \rightarrow \infty} \frac{h^i(t)}{t} = c^i := L \left(\int_0^L \frac{ds}{p^i(s)} \right)^{-1}, \quad i = 1, 2.$$

We will show below that $c^1 \neq c^2$ leads to a contradiction, and $c^1 = c^2$ implies $(u^1(t, x), h^1(t)) \equiv (u^2(t + t_1, x), h^2(t + t_1))$ for some $t_1 \in \mathbb{R}$. Such a strategy has been successfully used in [9] for the time-periodic case. Here we show that with adequate modifications, the strategy also works for the space-periodic case.

Theorem 3.1. *Let (u^1, h^1) and (u^2, h^2) be two pulsating semi-waves of (1.3). Then $(u^1(t, x), h^1(t)) \equiv (u^2(t + t_1, x), h^2(t + t_1))$ for some $t_1 \in \mathbb{R}$.*

Proof. After suitable translations in t , we may assume that $h^1(0) = h^2(0) = 0$. We now define (U^i, p^i) ($i = 1, 2$) as above. Then

$$t = \int_0^{h^i(t)} \frac{ds}{p^i(s)}, \quad i = 1, 2,$$

and

$$\lim_{t \rightarrow \infty} \frac{h^i(t)}{t} = c^i := L/T_i, \quad T_i := \int_0^L \frac{ds}{p^i(s)}, \quad i = 1, 2.$$

We will show that $c^1 = c^2$ implies $(u^1, h^1) \equiv (u^2, h^2)$, and $c^1 \neq c^2$ leads to a contradiction. This will be done in three steps below, with the above two facts proved in Steps 1 and 2 respectively, under the assumption of a fact to be proved in Step 3.

Step 1. $c^1 = c^2$ implies $(u^1, h^1) \equiv (u^2, h^2)$.

Since $c^1 = c^2$, we have $T_1 = T_2$. For convenience of notation we write $T_1 = T_2 = T$. Then $\tilde{h}(t) := h^1(t) - h^2(t)$ is a T -periodic function satisfying $\tilde{h}(0) = \tilde{h}(T) = 0$. If $\tilde{h} \equiv 0$, then clearly $p^1 \equiv p^2 > 0$, which implies $U^1 \equiv U^2$ by applying Proposition 2.5 with $\epsilon > 0$ sufficiently small (so that $p_\epsilon^1 = p^1$), and hence $u^1 \equiv u^2$, as we wanted. If $\tilde{h} \not\equiv 0$, we are going to derive a contradiction. In such a case, $C_0 := \max_{t \in \mathbb{R}} \tilde{h}(t) > 0$. For each $\sigma \geq 0$ we define $\tilde{h}_\sigma(t) := h^1(t) - h^2(t + \sigma)$ and $C_\sigma = \max_{t \in \mathbb{R}} \tilde{h}_\sigma(t)$. It is easily seen that C_σ is strictly decreasing in σ and there exists a unique $\sigma_0 > 0$ such that $C_{\sigma_0} = 0$. Therefore by shifting t to $t + \sigma_0$ in $(u^2(t, x), h^2(t))$, we may assume that, for some $t_0 \in [0, T)$,

$$h^1(t) \leq h^2(t) \quad \forall t \in \mathbb{R}, \quad h^1(t_0 + nT) = h^2(t_0 + nT), \quad n = 0, \pm 1, \pm 2, \dots$$

Hence

$$\frac{d}{dt} h^1(t_0 + nT) = \frac{d}{dt} h^2(t_0 + nT). \tag{3.1}$$

To derive a contradiction, we consider the function $W(t, r) := u^2(t, x) - u^1(t, x)$ for $(t, x) \in D := \{(t, x) \in \mathbb{R}^2: t \in \mathbb{R}, x \in (-\infty, h^1(t))\}$. Then clearly $W(t, r) \geq 0, \neq 0$ on ∂D with $W(t_0, h^1(t_0)) = 0$. We will show in Step 3 that this implies $W > 0$ in D , and $W_x(t_0, h^1(t_0)) < 0$, that is

$$u_x^1(t_0, h^1(t_0)) > u_x^2(t_0, h^2(t_0)), \quad \text{which leads to} \quad \frac{d}{dt} h^1(t_0) < \frac{d}{dt} h^2(t_0),$$

a contradiction to (3.1). Thus the conclusion of Step 1 will follow if we can show that

$$W_x(t_0, h^1(t_0)) < 0.$$

This will be done in Step 3 below.

Step 2. $c^1 \neq c^2$ leads to a contradiction.

Without loss of generality, we assume that $c^1 > c^2$. Then

$$\lim_{t \rightarrow \pm\infty} \frac{h^1(t)}{t} = c^1 > \lim_{t \rightarrow \pm\infty} \frac{h^2(t)}{t} = c^2. \tag{3.2}$$

This implies that the curves $x = h^1(t)$ and $x = h^2(t)$ have an intersection point (t_0, x_0) with a smallest t_0 value, namely

$$h^1(t) < h^2(t) \quad \text{for } t < t_0, \quad h^1(t_0) = h^2(t_0) = x_0.$$

It follows that

$$\frac{d}{dt}h^1(t_0) \geq \frac{d}{dt}h^2(t_0). \tag{3.3}$$

Define $W(t, r) := u^2(t, x) - u^1(t, x)$ for $(t, x) \in D_0 := \{(t, x) \in \mathbb{R}^2: t \in (-\infty, t_0], x \in (-\infty, h^1(t))\}$. Then $W > 0$ on $\partial D_0 \setminus \{(t, x): t = t_0\}$ and $W(t_0, x_0) = W(t_0, h^1(t_0)) = 0$. By Step 3 below, we have $W > 0$ in D_0 and $W_x(t_0, x_0) < 0$, which implies that

$$\frac{d}{dt}h^1(t_0) < \frac{d}{dt}h^2(t_0).$$

But this is in contradiction to (3.3). This completes the proof of the conclusion in Step 2, except that it remains to prove Step 3.

Step 3. Let W be as in Steps 1 and 2, then $W > 0$ in D and D_0 respectively, and $W_r(t_0, h^1(t_0)) < 0$.

We consider the case in Step 1 first. Let us recall that, by Proposition 2.3 and Remark 2.4, for $i = 1, 2$, $u^i(t, x) \rightarrow \phi(x)$ uniformly as $h^i(t) - x \rightarrow +\infty$. Moreover, $u^i(t, x) > 0$ in D and $u_x^i(t, h^i(t)) = -U_\xi^1(h^i(t), 0) < 0$ for all $t \in \mathbb{R}$, with $U_\xi^i(h^i(t), 0)$ periodic in t (of period T_i). Hence we can find a positive constant $c_0 > 0$ such that $u^2(t, x) \geq c_0 u^1(t, x)$ in D .

Define

$$c^* := \sup\{c > 0: u^2(t, x) \geq cu^1(t, x) \text{ in } D\}.$$

We clearly have $c^* \geq c_0 > 0$. Since $u^i(t, x) \rightarrow \phi(x)$ as $h^i(t) - x \rightarrow +\infty$, we also have $c^* \leq 1$. Thus $0 < c^* \leq 1$ and

$$W^*(t, x) := u^2(t, x) - c^*u^1(t, x) \geq 0 \quad \text{in } D.$$

Using $0 < c^* \leq 1$, we easily deduce from the equations for (u^i, h^i) that

$$\begin{cases} W_t^* - dW_{xx}^* + c(t, x)W^* \geq 0, & t \in \mathbb{R}, x < h^1(t), \\ W^*(t, h^1(t)) \geq, \neq 0, & t \in \mathbb{R}, \end{cases} \tag{3.4}$$

where $c(t, x) = -a(x) + b(x)[u^2(t, x) + c^*u^1(t, x)]$. Thus we can apply the strong maximum principle to (3.4) to conclude that the nonnegative function W^* is positive in D . Since $W^*(t_0, h^1(t_0)) = W(t_0, h^1(t_0)) = 0$, the Hopf lemma infers that $W_x^*(t_0, h^1(t_0)) < 0$. If we can show that $c^* = 1$, then $W^* = W$ and the required fact is proved.

We use an indirect argument to show that $c^* = 1$. Suppose by way of contradiction that $0 < c^* < 1$. Then by the definition of c^* , for any sequence of positive numbers $\epsilon_n \rightarrow 0$, there exists $(t_n, x_n) \in D$ such that

$$u^2(t_n, x_n) \leq (c^* + \epsilon_n)u^1(t_n, x_n) \quad \forall n \geq 1. \tag{3.5}$$

We may write $t_n = m_n T + \tilde{t}_n$ with m_n an integer and $\tilde{t}_n \in [0, T)$. Then $h^i(t_n) = h^i(\tilde{t}_n) + m_n L$ and $\tilde{h}(t_n) = \tilde{h}(\tilde{t}_n)$. By passing to a subsequence, we may assume that $\tilde{t}_n \rightarrow \tilde{t} \in [0, T]$. Then $\tilde{h}(t_n) = \tilde{h}(\tilde{t}_n) \rightarrow \tilde{h}(\tilde{t})$ as $n \rightarrow \infty$. We claim that $h^1(t_n) - x_n$ has an upper bound independent of n . Otherwise by passing to a subsequence we may assume that $h^1(t_n) - x_n \rightarrow \infty$ as $n \rightarrow \infty$. Then

$$h^2(t_n) - x_n \geq h^1(t_n) - x_n \rightarrow \infty$$

and hence, for $i = 1, 2$,

$$u^i(t_n, x_n) - \phi(x_n) \rightarrow 0 \quad \text{as } n \rightarrow \infty.$$

It follows from (3.5) that

$$\limsup_{n \rightarrow \infty} (1 - c^*)\phi(x_n) \leq 0.$$

On the other hand, there exists $\eta_0 > 0$ such that $\phi(x) \geq \eta_0$ for all $x \in \mathbb{R}$. Hence

$$\limsup_{n \rightarrow \infty} (1 - c^*)\phi(x_n) \geq (1 - c^*)\eta_0 > 0.$$

This contradiction proves our claim. Thus by passing to a subsequence we may assume that $h^1(t_n) - x_n \rightarrow \tilde{r} \in [0, \infty)$. Then

$$h^2(t_n) - x_n = h^1(t_n) - x_n - \tilde{h}(\tilde{t}_n) \rightarrow \tilde{r} - \tilde{h}(\tilde{t})$$

and making use of (3.5), the relationship $u^i(t, x) = U^i(h^i(t), h^i(t) - x)$ and

$$U^i(h^i(t_n), h^i(t_n) - x_n) = U^i(h^i(\tilde{t}_n), h^i(t_n) - x_n),$$

we deduce

$$U^2(h^2(\tilde{t}), \tilde{r} - \tilde{h}(\tilde{t})) \leq c^* U^1(h^1(\tilde{t}), \tilde{r}),$$

that is,

$$W^*(\tilde{t}, h^1(\tilde{t}) - \tilde{r}) \leq 0.$$

Since $W^* > 0$ in D , we necessarily have $\tilde{r} = 0$, $W^*(\tilde{t}, h^1(\tilde{t})) = 0$ and $W_x^*(\tilde{t}, h^1(\tilde{t})) < 0$. By continuity we can find positive constants ϵ_0 and δ_0 such that

$$W_x^*(t, h^1(t)) < -2\delta_0 \quad \forall t \in [\tilde{t} - \epsilon_0, \tilde{t} + \epsilon_0].$$

This implies that

$$W^*(t_n, x_n) = W^*(\tilde{t}_n, x_n - m_n L) \geq \delta_0 [h^1(\tilde{t}_n) - x_n + m_n L] \quad \text{for all large } n, \tag{3.6}$$

with

$$x_n - m_n L = h^1(\tilde{t}_n) + x_n - h^1(t_n) \rightarrow h^1(\tilde{t}) + \tilde{r} = h^1(\tilde{t}) \quad \text{as } n \rightarrow \infty,$$

due to $\tilde{r} = 0$ and $\tilde{t}_n \rightarrow \tilde{t}$. On the other hand, from $u^1(t, h^1(t)) = 0$ and $u_x^1(t, h^1(t)) = -(U^1)_x(h^1(t), 0) < 0$ we find that

$$u^1(t_n, x_n) = u^1(\tilde{t}_n, x_n - m_n L) \leq M_0 [h^1(\tilde{t}_n) - x_n + m_n L] \quad \text{for all large } n,$$

where $M_0 = 2 \max_{t \in [0, T]} U_x^1(h^1(t), 0)$. Thus for all large n , by (3.6), we have

$$u^2(t_n, x_n) \geq c^* u^1(t_n, x_n) + \delta_0 [h^1(\tilde{t}_n) - x_n + m_n L] \geq \left(c^* + \frac{\delta_0}{M_0} \right) u^1(t_n, x_n).$$

But this is in contradiction to (3.5). This proves $c^* = 1$ and thus $W > 0$ in D and $W_r(t_0, h^1(t_0)) < 0$, as required in Step 1.

The proof of the conclusion required in Step 2 follows a similar consideration. This time we define

$$c^* := \sup \{ c > 0 : u^2(t, x) \geq cu^1(t, x) \forall t \leq t_0, \forall x < h^1(t) \}.$$

We similarly have $c^* \geq c_0 > 0$ and $c^* \leq 1$. Thus

$$W^*(t, x) := u^2(t, x) - c^* u^1(t, x) \geq 0 \quad \forall t \leq t_0, \forall x \leq h^1(t).$$

Using $0 < c^* \leq 1$ and $h^2(t) > h^1(t)$ for $t < t_0$, we easily deduce

$$\begin{cases} W_t^* - dW_{xx}^* + c(t, x)W^* \geq 0, & t \leq t_0, x < h^1(t), \\ W^*(t, h^1(t)) > 0, & t < t_0, \end{cases} \tag{3.7}$$

where $c(t, x) = -a(x) + b(x)[u^2(t, x) + c^* u^1(t, x)]$. Thus we can apply the strong maximum principle to (3.7) to conclude that the nonnegative function W^* is positive in $D_0 = \{(t, x) : t \leq t_0, x < h^1(t)\}$. Since $W^*(t_0, h^1(t_0)) = W(t_0, h^1(t_0)) = 0$, the Hopf lemma infers that $W_x^*(t_0, h^1(t_0)) < 0$. If we can show that $c^* = 1$, then $W^* = W$ and the required fact is proved.

Suppose by way of contradiction that $0 < c^* < 1$. Then by the definition of c^* , for any sequence of positive numbers $\epsilon_n \rightarrow 0$, there exists $(t_n, x_n) \in D_0$ such that (3.5) holds. We claim that t_n has a lower bound that is independent of n . Otherwise, by passing to a subsequence we may assume that $t_n \rightarrow -\infty$ as $n \rightarrow \infty$. Then from (3.2) we deduce $h^2(t_n) - x_n \geq h^2(t_n) - h^1(t_n) \rightarrow +\infty$ as $n \rightarrow \infty$. It follows that

$$u^2(t_n, x_n) - \phi(x_n) \rightarrow 0 \quad \text{as } n \rightarrow \infty.$$

On the other hand we can show that

$$u^1(t_n, x_n) \leq \phi(x_n).$$

To see this, we compare u^1 with $v(t, x)$ which is the unique solution of the Cauchy problem

$$\begin{cases} v_t - dv_{xx} = v[a(x) - b(x)v], & t > 0, x \in \mathbb{R}, \\ v(0, x) = M, & x \in \mathbb{R}, \end{cases}$$

where $M > 0$ is chosen such that $\|u^1\|_\infty < M$. It is well known that $v(t, x) \rightarrow \phi(x)$ as $t \rightarrow \infty$. By the comparison principle, we have, for any $s \in \mathbb{R}^1$, $u^1(t + s, x) \leq v(t, x)$. Taking $s = s_0 - t$ we obtain $u^1(s_0, x) \leq v(t, x)$. Letting $t \rightarrow \infty$ it results $u^1(s_0, x) \leq \phi(x)$, and the required inequality follows by taking $(s_0, x) = (t_n, x_n)$.

Thus we can use (3.5) to deduce $\limsup_{n \rightarrow \infty} (1 - c^*)\phi(x_n) \leq 0$. This contradiction proves our claim. Hence we may assume, by passing to a subsequence, that $t_n \rightarrow \hat{t} \in (-\infty, t_0]$. We can now easily see that x_n has a lower bound independent of n , for otherwise we may assume that $x_n \rightarrow -\infty$, which leads to $h^i(t_n) - x_n \rightarrow +\infty$ and hence

$$u^i(t_n, x_n) - \phi(x_n) \rightarrow 0 \quad \text{as } n \rightarrow \infty,$$

which again implies $\limsup_{n \rightarrow \infty} (1 - c^*)\phi(x_n) \leq 0$. Thus we may assume that $x_n \rightarrow \hat{x} \in (-\infty, h^1(\hat{t})]$ as $n \rightarrow \infty$. Letting $n \rightarrow \infty$ in (3.5), we deduce $u^2(\hat{t}, \hat{x}) \leq c^*u^1(\hat{t}, \hat{x})$, that is $W^*(\hat{t}, \hat{x}) \leq 0$. Since $W^* > 0$ in $D \cup \{(t, x) : x = h^1(t), t < t_0\}$, we necessarily have $(\hat{t}, \hat{x}) = (t_0, h^1(t_0))$ and $W^*(t_0, h^1(t_0)) = 0$. By the Hopf lemma we have $W_x^*(t_0, h^1(t_0)) < 0$, and we can then derive a contradiction to (3.5) as before. The proof is now complete. \square

3.2. Monotonicity in t

We show that if $(u(t, x), h(t))$ is a pulsating semi-wave, then $u(t, x)$ is strictly increasing in t .

Theorem 3.2. *Let $(u(t, x), h(t))$ be a pulsating semi-wave of (1.3). Then $u_t(t, x) > 0$ for $x \leq h(t)$, $t \in \mathbb{R}$.*

This theorem is a simple consequence of the following lemma, which implies $u_t \geq 0$, but a simple application of the strong maximum principle then shows $u_t > 0$.

Lemma 3.3. *Suppose that $p \in C^1_L(\mathbb{R})$ and $p(\tau) > 0$ in \mathbb{R} . Let $U(\tau, \xi)$ be the maximal nonnegative L -periodic in τ solution of (2.1). Then $U_\tau + U_\xi \geq 0$ in $\mathbb{R} \times (0, \infty)$.*

Proof. Since $p(\tau)$ is periodic, there exists $\delta_0 > 0$ such that $p(\tau) \geq \delta_0$ for all $\tau \in \mathbb{R}$. Therefore (2.1) and (2.3) are the same for $\epsilon \in (0, \delta_0]$. We fix such an ϵ in (2.3). In view of Proposition 2.5, $U(\tau, \xi)$ is either identically zero or $U(\tau, \xi) > 0$ in $\mathbb{R} \times (0, \infty)$. In the former case, clearly $U_\tau + U_\xi \equiv 0$.

It remains to show that $U_\tau + U_\xi \geq 0$ in $\mathbb{R} \times (0, \infty)$ when $U > 0$. Let $u(t, x) = U(h(t), h(t) - x)$ with $h(t)$ determined by

$$h'(t) = p(h(t)), \quad h(0) = 0.$$

Then u is a positive solution to

$$\begin{cases} u_t - du_{xx} = u[a(x) - b(x)u], & t \in \mathbb{R}, x < h(t), \\ u(t, h(t)) = 0, & t \in \mathbb{R}. \end{cases} \tag{3.8}$$

Since $u_t = h'(t)(U_\tau + U_\xi)$, it suffices to show that $u_t \geq 0$, or equivalently, $u(t + \sigma, x) \geq u(t, x)$ for any $\sigma > 0$. Fix $\sigma > 0$ and denote $u^\sigma(t, x) = u(t + \sigma, x)$. Clearly u^σ satisfies (3.8) except that $h(t)$ there should be replaced by $h(t + \sigma)$.

We first prove that there exists $M > 0$ such that $Mu^\sigma(t, x) \geq u(t, x)$ for $x \leq h(t)$ and $t \in \mathbb{R}$. From [Proposition 2.5](#), we have

$$\lim_{\xi \rightarrow +\infty} [U(\tau, \xi) - \bar{U}^{p,\epsilon}(\tau, \xi)] = 0 \quad \text{uniformly in } \tau \in \mathbb{R}.$$

By [Remark 2.4](#) we have $\bar{U}^{p,\epsilon}(h(t), h(t) - x) \equiv \phi(x)$, where ϕ is the unique positive periodic solution of

$$-d\phi_{xx} = \phi[a(x) - b(x)\phi], \quad x \in \mathbb{R}.$$

It follows that

$$\lim_{h(t)-x \rightarrow +\infty} [u(t, x) - \phi(x)] = 0 \quad \text{uniformly.}$$

Similarly

$$\lim_{h(t)-x \rightarrow +\infty} [u^\sigma(t, x) - \phi(x)] = 0 \quad \text{uniformly.}$$

Therefore, for any given $M_0 > 1$, there exists $R = R_{M_0} > 0$ such that $h(t) - x \geq R$ and $M \geq M_0$ imply

$$Mu^\sigma(t, x) - u(t, x) \geq \frac{M_0 - 1}{2} \phi(x) > 0. \tag{3.9}$$

For $h(t) - x \in [0, R]$, we have

$$u(t, x) = U(h(t), h(t) - x) \leq \sigma_1 := \max_{(\tau, \xi) \in [0, L] \times [0, R]} U(\tau, \xi) < +\infty,$$

and

$$u^\sigma(t, x) = U(h(t + \sigma), h(t + \sigma) - x) \geq \sigma_2 := \min_{(\tau, \xi) \in [0, L] \times [\xi_0, \xi^0]} U(\tau, \xi) > 0, \tag{3.10}$$

where $\xi_0 = \inf_{t \in \mathbb{R}} [h(t + \sigma) - h(t)] > 0$, $\xi^0 = \sup_{t \in \mathbb{R}} [h(t + \sigma) - h(t)] + R < +\infty$. Therefore, if $M \geq M_0$ satisfies $M\sigma_2 \geq \sigma_1$, then

$$Mu^\sigma(t, x) \geq u(t, x) \quad \text{for } x \leq h(t), \quad t \in \mathbb{R}.$$

Define

$$M_* := \inf\{M > 0: Mu^\sigma(t, x) \geq u(t, x) \text{ for } x \leq h(t), t \in \mathbb{R}\}.$$

To complete the proof of the theorem, it suffices to show that $M_* \leq 1$.

In the following, we assume $M_* > 1$ and deduce a contradiction. By definition, we have

$$M_* u^\sigma(t, x) \geq u(t, x) \quad \forall x \leq h(t), t \in \mathbb{R}, \tag{3.11}$$

and there exists (t_n, x_n) such that

$$x_n \leq h(t_n), \quad (M_* - \epsilon_n)u^\sigma(t_n, x_n) \leq u(t_n, x_n), \quad n = 1, 2, \dots, \tag{3.12}$$

where $\{\epsilon_n\}$ is a decreasing sequence converging to 0 as $n \rightarrow \infty$. We may assume that $M_* - \epsilon_1 > 1$.

Take $M_0 = M_* - \epsilon_1$ and $M = M_* - \epsilon_n$ in [\(3.9\)](#), we obtain

$$(M_* - \epsilon_n)u^\sigma(t, x) > u(t, x) \quad \text{for } h(t) - x \geq R_0 := R_{M_0}, t \in \mathbb{R}.$$

It follows that

$$\xi_n := h(t_n) - x_n \in (0, R_0), \quad n = 1, 2, \dots$$

Write

$$h(t_n) = k_n L + \tau_n, \quad \text{with } k_n \text{ an integer and } \tau_n \in [0, L].$$

We may assume that

$$(\tau_n, \xi_n) \rightarrow (\tau_\infty, \xi_\infty) \in [0, L] \times [0, R_0].$$

Define

$$u^n(t, x) = u(t_n + t, x_n + x) \quad \text{for } t \in \mathbb{R}, x_n + x < h(t_n + t).$$

Clearly

$$h(t_n + t) - x_n = \xi_n + \tilde{h}_n(t)$$

with

$$\tilde{h}_n(t) = h(t_n + t) - h(t_n) = \int_0^t p(h(t_n + s)) ds = \int_0^t p(\tilde{h}_n(s) + \tau_n) ds.$$

Moreover, u^n satisfies

$$u_t^n - du_{xx}^n = u^n[a(x_n + x) - b(x_n + x)u^n] \quad \text{for } x \leq \xi_n + \tilde{h}_n(t) =: h_n(t),$$

and

$$u^n(t, h_n(t)) \equiv 0,$$

with

$$a(x_n + x) = a(h(t_n) - \xi_n + x) = a(\tau_n - \xi_n + x) =: a_n(x),$$

$$b(x_n - x) = b(\tau_n - \xi_n + x) =: b_n(x).$$

Clearly

$$a_n(x) \rightarrow a_\infty(x) := a(\tau_\infty - \xi_\infty + x), \quad b_n(x) \rightarrow b_\infty(x) := b(\tau_\infty - \xi_\infty + x)$$

in $C_L^\delta(\mathbb{R})$. Since $\tilde{h}_n(\cdot)$ is uniformly continuous, by passing to a subsequence we may assume that $\tilde{h}_n(\cdot) \rightarrow \hat{h}(\cdot)$ in $C_{loc}^0(\mathbb{R})$. It follows that

$$\tilde{h}_n(t) \rightarrow h_\infty(t) := \int_0^t p(\hat{h}(s) + \tau_\infty) ds \quad \text{in } C_{loc}^1(\mathbb{R}).$$

We may now apply standard parabolic L^p estimates to the equation satisfied by u^n to conclude that, subject to passing to a subsequence, $u^n \rightarrow u^\infty$ locally uniformly in $\{(t, x) : x < h_\infty(t), t \in \mathbb{R}\}$, and u^∞ satisfies

$$u_t^\infty - du_{xx}^\infty = u^\infty[a_\infty(x) - b_\infty(x)u^\infty] \quad \text{for } x < h_\infty(t), t \in \mathbb{R}.$$

Moreover, one may straighten the boundary $x = h_n(t)$ in the equation of u^n and then apply the regularity theory to the modified equation near the straightened boundary to conclude that u^∞ is smooth up to $x = h_\infty(t)$, with $u^\infty(t, h_\infty(t)) \equiv 0$.

Similarly, by passing to a further subsequence, $u^{\sigma, n}(t, x) := u^\sigma(t_n + t, x_n + x)$ converges to some function $v^\infty(t, x)$ which satisfies

$$\begin{cases} v_t^\infty - dv_{xx}^\infty = v^\infty[a_\infty(x) - b_\infty(x)v^\infty], & x < h_\infty(t + \sigma), t \in \mathbb{R}, \\ v^\infty(t, h_\infty(t + \sigma)) = 0, & t \in \mathbb{R}. \end{cases}$$

By (3.11) and (3.12), we obtain

$$M_* v^\infty(t, x) \geq u^\infty(t, x) \quad \text{for } x \leq h_\infty(t), t \in \mathbb{R},$$

and

$$M_* v^\infty(0, 0) = u^\infty(0, 0).$$

By (3.10), we have $v^\infty(0, 0) \geq \sigma_2 > 0$. Therefore u^∞ and v^∞ are positive solutions, and $0 < h_\infty(0)$. Since $M_* > 1$, $V^\infty := M_* v^\infty$ satisfies

$$V_t^\infty - dV_{xx}^\infty \geq V^\infty[a_\infty(x) - b_\infty(x)V^\infty] \quad \text{for } x \leq h_\infty(t + \sigma), t \in \mathbb{R}.$$

Thus $z := V^\infty - u^\infty$ satisfies, for some bounded $c(t, x)$,

$$z_t - dz_{xx} \geq c(t, x)z, \quad z \geq 0 \text{ for } x < h_\infty(t), \quad t \in \mathbb{R},$$

and z achieves its minimum 0 at $(0, 0)$. Since $(0, 0)$ is an interior point of the domain $\{(t, x) : x < h_\infty(t), t \in \mathbb{R}\}$, by the strong maximum principle, we deduce $z \equiv 0$. But z is continuous and is positive on $x = h_\infty(t)$ (note that h_∞ is strictly increasing). This contradiction completes our proof. \square

3.3. Continuous dependence on parameters

In this subsection, we show that the pulsating semi-wave $(u(t, x), h(t))$, when normalized by requiring $h(0) = 0$, depends continuously on $(d, \mu, a, b) \in \mathbb{R}^2 \times C_L^v(\mathbb{R})^2$.

Theorem 3.4. *Suppose that, as $n \rightarrow \infty$, $(d_n, \mu_n, a_n, b_n) \rightarrow (d_0, \mu_0, a_0, b_0)$ in $\mathbb{R}^2 \times C_L^v(\mathbb{R})^2$, with $d_0, \mu_0 > 0$, $a_0(x), b_0(x) > 0$. Let (u^n, h^n) denote the unique normalized pulsating semi-wave of (1.3), with $(d, \mu, a, b) = (d_n, \mu_n, a_n, b_n)$, $n = 0, 1, 2, \dots$. Then $\lim_{n \rightarrow \infty} [h^n(t) - h^0(t)] = 0$ uniformly in \mathbb{R} , and $\lim_{n \rightarrow \infty} [u^n(t, x) - u^0(t, x)] = 0$ locally uniformly in $\{(t, x) : x < h^0(t), t \in \mathbb{R}\}$.*

Proof. Choose positive constants A and B such that $A \geq \max a_n$, $B \leq \min b_n$ for $n = 0, 1, 2, \dots$. Let $v(\xi)$ be the unique positive solution to

$$-v'' = v(A - Bv) \quad \text{for } \xi > 0, \quad v(0) = 0.$$

Then it is well known (see [10]) that $v'(\xi) > 0$ and $v(+\infty) = A/B$. We define $v_n(\xi) = v(\xi/\sqrt{d_n})$. Clearly

$$-d_n v_n'' = v_n(A - Bv_n) \quad \text{for } \xi > 0, \quad v_n(0) = 0.$$

Let $(U^n(\tau, \xi), p^n(\tau))$ be the corresponding pair to $(u^n(x), h^n(t))$, as before. Then

$$\begin{aligned} p^n(\tau)(U_\tau^n + \hat{U}_\xi) - d_n U_{\xi\xi}^n &= U^n[a_n(\tau - \xi) - b_n(\tau - \xi)U^n], \quad (\tau, \xi) \in \mathbb{R} \times [0, \infty), \\ U^n(\tau, 0) = 0, \quad p^n(\tau) &= \mu_n U_\xi^n(\tau, 0), \quad \tau \in \mathbb{R}, \end{aligned}$$

and much as at the beginning of the proof of Proposition 2.5, we can use a comparison argument to conclude that $U^n(\tau, \xi) \leq v_n(\xi)$ for $\tau \in \mathbb{R}$ and $\xi > 0$. It follows that $U_\xi^n(\tau, 0) \leq v_n'(0)$ and hence

$$0 < p^n(\tau) \leq \mu_n v_n'(0) = \frac{\mu_n}{\sqrt{d_n}} v'(0), \quad n = 0, 1, 2, \dots$$

Thus $\{p^n\}$ is bounded in $C_L^0(\mathbb{R})$. Checking the proof of Proposition 2.9 we find that there exists $\epsilon > 0$ independent of n such that $p^n(\tau) \geq \epsilon$ for all $\tau \in \mathbb{R}$ and $n = 0, 1, 2, \dots$. Therefore, in view of $0 < U^n \leq v_n \leq A/B$, we may apply standard L^p theory for parabolic equations to conclude that $\{U^n\}$ is a bounded set in $W_q^{1,2}([0, L] \times [0, M])$ ($\forall q > 1, \forall M > 0$). By Sobolev embedding we see that $\{U^n\}$ is a bounded set in $C^{\frac{1+\nu_0}{2}, 1+\nu_0}([0, L] \times [0, M])$ with $\nu_0 \in (\nu, 1)$. Therefore by passing to a subsequence we may assume that $p^n(\tau) = \mu U_\xi^n(\tau, 0) \rightarrow \hat{p}(\tau)$ in $C_L^v(\mathbb{R})$. By a standard diagonal process and by passing to a further subsequence if necessary, we may assume that $U^n \rightarrow \hat{U}$ in $C_{loc}^{\frac{\nu+1}{2}, \nu+1}([0, L] \times [0, \infty))$. Thus (\hat{U}, \hat{p}) satisfies

$$\begin{aligned} \hat{p}(\tau)(\hat{U}_\tau + \hat{U}_\xi) - d_0 \hat{U}_{\xi\xi} &= \hat{U}[a_0(\tau - \xi) - b_0(\tau - \xi)\hat{U}], \quad (\tau, \xi) \in \mathbb{R} \times [0, \infty), \\ \hat{U}(\tau, 0) = 0, \quad \hat{p}(\tau) &= \mu_0 \hat{U}_\xi(\tau, 0), \quad \tau \in \mathbb{R}. \end{aligned}$$

Therefore $(\hat{u}(t, x), \hat{h}(t))$ defined by

$$\hat{u}(t, x) = \hat{U}(\hat{h}(t), \hat{h}(t) - x), \quad t = \int_0^{\hat{h}(t)} \frac{1}{\hat{p}(\tau)} d\tau$$

is a normalized pulsating semi-wave of (1.3) with $(d, \mu, a, b) = (d_0, \mu_0, a_0, b_0)$. By uniqueness, necessarily $(\hat{u}, \hat{h}) = (u^0, h^0)$. This implies that the entire sequence (u^n, h^n) converges to (u^0, h^0) as stated in the theorem. \square

4. Spreading speed

In this section we study the spreading speed determined by (1.1) when spreading occurs. We also investigate how this speed varies with μ .

Let (\tilde{u}, \tilde{h}) be a pulsating semi-wave of (1.3), which is unique up to a translation of t . Let the function pair (U, p) be given by

$$U(\tau, \xi) = \tilde{u}(\tilde{h}^{-1}(\tau), \tau - \xi), \quad p(\tau) = -\mu \tilde{u}_x(\tilde{h}^{-1}(\tau), \tau).$$

Then we have

$$\tilde{h}'(t) = p(\tilde{h}(t)) \quad \text{and} \quad \lim_{t \rightarrow \infty} \tilde{h}(t)/t = L/T \quad \text{with} \quad T = \int_0^L \frac{ds}{p(s)}.$$

Let us note that the first identity in the line above implies that

$$\int_{\tilde{h}(t_0)}^{\tilde{h}(t_0+t)} \frac{ds}{p(s)} = t \quad \forall t_0, t \in \mathbb{R}.$$

This implies that if (\hat{U}, \hat{p}) is obtained from a pulsating semi-wave which is a shift of (\tilde{u}, \tilde{h}) in t , then $\hat{p}(\tau)$ is identical to $p(\tau + \tau_0)$ for some $\tau_0 \in \mathbb{R}$. Since $p(\tau)$ is L -periodic, we find that $\int_0^L \frac{ds}{p(s)}$ is independent of the choice of (\tilde{u}, \tilde{h}) . Thus the quantity L/T is uniquely determined.

Our first main result of this section is the following.

Theorem 4.1. *Suppose that (u, h) is the unique solution of (1.1) and $\lim_{t \rightarrow \infty} h(t) = +\infty$. Then*

$$\lim_{t \rightarrow \infty} \frac{h(t)}{t} = \lim_{t \rightarrow \infty} \frac{\tilde{h}(t)}{t} = \frac{L}{T}. \tag{4.1}$$

Proof. Fix $\epsilon > 0$ small and for $\sigma \in \{\epsilon, -\epsilon\}$, we denote by (u^σ, h^σ) the unique pulsating semi-wave of

$$\begin{cases} u_t - du_{xx} = u([a(x) + \sigma] - [b(x) - \sigma]u), & x < h(t), \quad t \in \mathbb{R}, \\ h'(t) = -(1 - \sigma)\mu u_x(t, h(t)), & u(t, h(t)) = 0, \quad t \in \mathbb{R}, \end{cases}$$

normalized by $h^\sigma(0) = 0$. Define

$$\tilde{u}^\sigma(t, x) = u^\sigma\left(\frac{t}{1 - \sigma}, x\right), \quad \tilde{h}^\sigma(t) = h^\sigma\left(\frac{t}{1 - \sigma}\right).$$

Then

$$\begin{cases} (1 - \sigma)\tilde{u}_t^\sigma - d\tilde{u}_{xx}^\sigma = \tilde{u}^\sigma([a(x) + \sigma] - [b(x) - \sigma]\tilde{u}^\sigma), & x < \tilde{h}^\sigma(t), \quad t \in \mathbb{R}, \\ (\tilde{h}^\sigma)'(t) = -\mu \tilde{u}_x^\sigma(t, \tilde{h}^\sigma(t)), & \tilde{u}^\sigma(t, \tilde{h}^\sigma(t)) = 0, \quad t \in \mathbb{R}. \end{cases}$$

Set

$$\begin{aligned} (\bar{u}^\epsilon(t, x), \bar{h}^\epsilon(t)) &= (\tilde{u}^\epsilon(t + C_1, x), \tilde{h}^\epsilon(t + C_1)), \\ (\underline{u}^\epsilon(t, x), \underline{h}^\epsilon(t)) &= (\tilde{u}^{-\epsilon}(t + C_2, x), \tilde{h}^{-\epsilon}(t + C_2)). \end{aligned}$$

We will show that, for all small $\epsilon > 0$ and suitable $C_1, C_2, M \in \mathbb{R}$,

$$\begin{cases} \underline{u}^\epsilon(t, r) \leq u(t, r) \leq \bar{u}^\epsilon(t, r) & \text{for } t \geq M, \quad r \in [M, \underline{h}^\epsilon(t)], \\ \underline{h}^\epsilon(t) \leq h(t) \leq \bar{h}^\epsilon(t) & \text{for } t \geq M. \end{cases} \tag{4.2}$$

If (4.2) is proved, then we have

$$\lim_{t \rightarrow \infty} \frac{\underline{h}^\epsilon(t)}{t} \leq \liminf_{t \rightarrow \infty} \frac{h(t)}{t} \leq \limsup_{t \rightarrow \infty} \frac{h(t)}{t} \leq \lim_{t \rightarrow \infty} \frac{\bar{h}^\epsilon(t)}{t}.$$

Clearly

$$\lim_{t \rightarrow \infty} \frac{h^\epsilon(t)}{t} = \lim_{t \rightarrow \infty} \frac{h^{-\epsilon}((t + C_2)/(1 + \epsilon))}{t} = (1 + \epsilon)^{-1} L / T_\epsilon,$$

and

$$\lim_{t \rightarrow \infty} \frac{\bar{h}^\epsilon(t)}{t} = \lim_{t \rightarrow \infty} \frac{h^\epsilon((t + C_1)/(1 - \epsilon))}{t} = (1 - \epsilon)^{-1} L / T^\epsilon,$$

where $T_\epsilon = \int_0^L \frac{ds}{p^\epsilon(s)}$, with $\underline{p}^\epsilon(\tau) := -\mu \underline{u}_x^\epsilon((\underline{h}^\epsilon)^{-1}(\tau), \tau)$; T^ϵ is defined analogously from $(\bar{u}^\epsilon, \bar{h}^\epsilon)$.

It follows that

$$(1 + \epsilon)^{-1} L / T_\epsilon \leq \liminf_{t \rightarrow \infty} \frac{h(t)}{t} \leq \limsup_{t \rightarrow \infty} \frac{h(t)}{t} \leq (1 - \epsilon)^{-1} L / T^\epsilon.$$

Letting $\epsilon \rightarrow 0$, we deduce

$$\lim_{t \rightarrow \infty} \frac{h(t)}{t} = \frac{L}{T},$$

as desired.

It remains to prove (4.2). This will follow from the comparison principle by showing that $(\bar{u}^\epsilon, \bar{h}^\epsilon)$ and $(\underline{u}^\epsilon, \underline{h}^\epsilon)$ are respectively upper and lower solutions to (1.1) for $t \geq M$. We break the argument below into several steps.

Step 1. For any large $R = R_\epsilon > 0$ satisfying

$$\alpha(r) \in \left[a(r) - \frac{\epsilon}{2}, a(r) + \frac{\epsilon}{2} \right], \quad \beta(r) \in \left[b(r) - \frac{\epsilon}{2}, b(r) + \frac{\epsilon}{2} \right] \quad \forall r \geq R,$$

there exists $\tau_R > 0$ such that

$$\underline{u}_t^\epsilon - d \Delta \underline{u}^\epsilon \leq \underline{u}^\epsilon [\alpha(r) - \beta(r) \underline{u}^\epsilon], \quad r \in [\tau_R, \underline{h}^\epsilon(t)], \tag{4.3}$$

$$\bar{u}_t^\epsilon - d \Delta \bar{u}^\epsilon \geq \bar{u}^\epsilon [\alpha(r) - \beta(r) \bar{u}^\epsilon], \quad r \in [\tau_R, \bar{h}^\epsilon(t)], \tag{4.4}$$

with the inequalities satisfied for all t such that $\underline{h}^\epsilon(t) > \tau_R$ and $\bar{h}^\epsilon(t) > \tau_R$, respectively.

To prove (4.3), we note that

$$\begin{aligned} & \underline{u}^\epsilon \{ [a(r) - \epsilon] - [b(r) + \epsilon] \underline{u}^\epsilon \} + \frac{\epsilon}{2} \underline{u}^\epsilon \\ & \leq \underline{u}^\epsilon [\alpha(r) - \beta(r) \underline{u}^\epsilon] \quad \text{for } r \in [R, \underline{h}^\epsilon(t)]. \end{aligned}$$

Therefore, in view of the equation satisfied by \underline{u}^ϵ , (4.3) will follow if we have

$$\begin{aligned} & \underline{u}_t^\epsilon - d \left(\underline{u}_{rr}^\epsilon + \frac{N-1}{r} \underline{u}_r^\epsilon \right) \\ & \leq (1 + \epsilon) \underline{u}_t^\epsilon - d \underline{u}_{rr}^\epsilon + \frac{\epsilon}{2} \underline{u}^\epsilon \quad \text{for } r \in [\tau_R, \underline{h}^\epsilon(t)], \end{aligned}$$

or equivalently,

$$-d \frac{N-1}{r} \underline{u}_r^\epsilon \leq \epsilon \underline{u}_t^\epsilon + \frac{\epsilon}{2} \underline{u}^\epsilon \quad \text{for } r \in [\tau_R, \underline{h}^\epsilon(t)]. \tag{4.5}$$

From the identity $\underline{u}^\epsilon(t, \underline{h}^\epsilon(t)) \equiv 0$, we deduce

$$\underline{u}_r^\epsilon(t, r) + (\underline{h}^\epsilon)'(t) \underline{u}_r^\epsilon(t, r) = 0 \quad \text{for } r = \underline{h}^\epsilon(t).$$

Therefore

$$-\underline{u}_r^\epsilon(t, r) = [(\underline{h}^\epsilon)'(t)]^{-1} \underline{u}_r^\epsilon(t, r) > 0 \quad \text{for } r = \underline{h}^\epsilon(t).$$

Moreover, the functions $\underline{u}^\epsilon(t, \underline{h}^\epsilon(t))$, $\underline{u}_t^\epsilon(t, \underline{h}^\epsilon(t))$ and $\underline{u}_r^\epsilon(t, \underline{h}^\epsilon(t))$ are periodic in t (recalling the transform $u(t, x) = U(h(t), h(t) - x)$). Hence, from the uniform continuity of \underline{u}^ϵ , \underline{u}_t^ϵ and \underline{u}_r^ϵ on $(t, \xi) = (t, \underline{h}^\epsilon(t) - r)$, we can find $\delta = \delta_\epsilon > 0$ such that

$$-\underline{u}_r^\epsilon(t, r) \leq \sigma_0 \underline{u}_t^\epsilon(t, r) \quad \text{for } r \in [\underline{h}^\epsilon(t) - \delta, \underline{h}^\epsilon(t)], \quad t \in \mathbb{R},$$

where $\sigma_0 = 2 \max_{t \in \mathbb{R}} [(\underline{h}^\epsilon)'(t)]^{-1}$. It follows that (4.5) holds in the range $r \in [\underline{h}^\epsilon(t) - \delta, \underline{h}^\epsilon(t)]$ provided that $\underline{h}^\epsilon(t) - \delta > R_1$, where $R_1 := d(N - 1)\sigma_0/\epsilon$.

For $r \in (-\infty, \underline{h}^\epsilon(t) - \delta]$, we have $\underline{u}^\epsilon \geq \sigma_1 > 0$ and $|\underline{u}_r^\epsilon| \leq \sigma_2 < +\infty$. Thus (4.5) holds for $r \in [\tau_R, \underline{h}^\epsilon(t)]$ with

$$\tau_R := \max \left\{ \frac{2d(N - 1)\sigma_2}{\epsilon\sigma_1}, R_1, R \right\}.$$

The proof of (4.4) is similar and we omit the details.

Step 2. There exist $R_0 \geq \tau_R$ and $T_1 > 0$ such that,

$$\bar{h}^\epsilon(T_1) > h(T_1), \quad \underline{h}^\epsilon(T_1) < R_0 < h(T_1)$$

and

$$\bar{u}^\epsilon(t, R_0) \geq u(t, R_0), \quad \underline{u}^\epsilon(t, R_0) \leq u(t, R_0) \quad \text{for } t \geq T_1.$$

For $\sigma \in \{\epsilon, 0, -\epsilon\}$, let $\phi^\sigma(x)$ be the unique positive solution of

$$-d\phi_{xx} = \phi \{ [a(x) + \sigma] - [b(x) - \sigma]\phi \}, \quad x \in \mathbb{R}.$$

Then ϕ^σ is L -periodic and $\phi^\epsilon > \phi^0 > \phi^{-\epsilon}$. Hence there exists $\delta = \delta_\epsilon > 0$ such that

$$\phi^\epsilon(x) - 2\delta \geq \phi^0(x) \geq \phi^{-\epsilon}(x) + 2\delta, \quad x \in \mathbb{R}.$$

Let $(u(t, r), h(t))$ be the unique solution of (1.1), for which spreading occurs. By Theorem 2.4 of [7], we have

$$\lim_{t \rightarrow \infty} u(t, r) = \hat{U}(r) \quad \text{locally uniformly for } r \in [0, \infty),$$

where \hat{U} is the unique positive solution of

$$-d \left(U'' + \frac{N-1}{r} U' \right) = U[a(r) - b(r)U] \quad \text{for } r \in [0, \infty). U'(0) = 0.$$

For any sequence $r_n \rightarrow \infty$, write $r_n = m_n L + \tilde{r}_n$ with m_n an integer and $\tilde{r}_n \in [0, L)$, and define $U_n(r) = \hat{U}(r_n + r)$. Then by passing to a subsequence one may assume that $\tilde{r}_n \rightarrow r_*$. Applying the L^p theory to the equation of U_n , and using Sobolev embedding, one finds that by passing to a further subsequence, $U_n \rightarrow U_*$ in $C^1_{loc}(\mathbb{R})$, and U_* satisfies

$$-dU_*'' = U_*^*[a(r_* + r) - b(r_* + r)U_*] \quad \text{in } \mathbb{R}.$$

A simple upper and lower solution consideration shows that $U_* > 0$. Therefore necessarily $U_*(r) = \phi^0(r_* + r)$. This implies that

$$\lim_{r \rightarrow \infty} [\hat{U}(r) - \phi^0(r)] = 0.$$

It follows that, with the above chosen δ , there exist $R_0 \geq \tau_R$ and $T_0 > 0$ such that

$$u(t, R_0) \in [\phi^0(R_0) - \delta, \phi^0(R_0) + \delta] \quad \text{for } t \geq T_0.$$

On the other hand, we have

$$\lim_{\bar{h}^\epsilon(t) - x \rightarrow \infty} [\bar{u}^\epsilon(t, x) - \phi^\epsilon(x)] = 0, \quad \lim_{\underline{h}^\epsilon(t) - x \rightarrow \infty} [\underline{u}^\epsilon(t, x) - \phi^{-\epsilon}(x)] = 0.$$

It follows that

$$\lim_{t \rightarrow \infty} [\bar{u}^\epsilon(t, R_0) - \phi^\epsilon(R_0)] = 0, \quad \lim_{t \rightarrow \infty} [\underline{u}^\epsilon(t, R_0) - \phi^{-\epsilon}(R_0)] = 0.$$

Therefore by enlarging T_0 properly we may assume that

$$\bar{u}^\epsilon(t, R_0) \geq \phi^\epsilon(R_0) - \delta, \quad \underline{u}^\epsilon(t, R_0) \leq \phi^{-\epsilon}(R_0) + \delta \quad \text{for } t \geq T_0.$$

Hence

$$\bar{u}^\epsilon(t, R_0) \geq \phi^0(R_0) + \delta \geq u(t, R_0), \quad \underline{u}^\epsilon(t, R_0) \leq \phi^0(R_0) - \delta \leq u(t, R_0) \quad \text{for } t \geq T_0. \tag{4.6}$$

Recall that

$$\bar{h}^\epsilon(t) = h^\epsilon \left(\frac{t + C_1}{1 + \epsilon} \right), \quad \underline{h}^\epsilon(t) = h^{-\epsilon} \left(\frac{t + C_2}{1 - \epsilon} \right),$$

and in the above discussion, we only used an arbitrarily fixed pair (C_1, C_2) . Next we choose C_1 and C_2 to meet the required inequalities of this step. Since $\bar{u}^\epsilon(t, x)$ and $\underline{u}^\epsilon(t, x)$ are both increasing in t , we find that the inequalities in (4.6) remain valid when C_1 is increased and C_2 is decreased. We first choose $T_1 \geq T_0$ such that $h(T_1) > R_0$. We may then increase C_1 and decrease C_2 properly to guarantee that

$$\bar{h}^\epsilon(T_1) > h(T_1), \quad \underline{h}^\epsilon(T_1) < R_0.$$

This completes the proof of Step 2.

Step 3. Completion of the proof.

Since $\underline{h}^\epsilon(T_1) < R_0 < h(T_1)$, there exists $T_2 > T_1$ such that

$$\underline{h}^\epsilon(T_2) = R_0 < h(T_2).$$

Therefore we can find $\eta > 0$ sufficiently small such that

$$R_0 < \underline{h}^\epsilon(T_2 + \eta) < h(T_2 + \eta), \quad \underline{u}^\epsilon(T_2 + \eta, r) < u(T_2 + \eta, r) \quad \text{for } r \in [R_0, \underline{h}^\epsilon(T_2 + \eta)].$$

We may now use the conclusions in Steps 1 and 2, and apply the comparison principle (see Lemma 3.3 in [7]), to conclude that

$$h(t) \geq \underline{h}^\epsilon(t), \quad u(t, r) \geq \underline{u}^\epsilon(t, r) \quad \text{for } r \in [R_0, \underline{h}^\epsilon(t)], \quad t \geq T_2 + \eta.$$

Let $V(t, r)$ be the unique solution of

$$V_t - d\Delta V = V[\alpha(r) - \beta(r)V], \quad r \in [0, \infty), \quad V_r(t, 0) = 0, \quad V(0, r) = \|u_0\|_\infty.$$

Then it is well known that $\lim_{t \rightarrow \infty} \|V(t, \cdot) - \hat{U}(\cdot)\|_{L^\infty([0, \infty))} = 0$. By the comparison principle we have $u(t, r) \leq V(t, r)$ for $r \in [0, h(t)]$, $t > 0$. It follows that $\limsup_{t \rightarrow \infty} u(t, r) \leq \hat{U}(r)$ uniformly for $r \in [0, \infty)$. Therefore, if R_0 and T_0 are large enough in Step 2, we have

$$u(t, r) \leq \phi^0(r) + \delta \leq \phi^\epsilon(r) - \delta \quad \text{for } r \in [R_0, h(t)], \quad t \geq T_0,$$

where $\delta > 0$ is as in Step 2. If C_1 is sufficiently large, we can guarantee that

$$\bar{u}^\epsilon(T_1, r) \geq \phi^\epsilon(r) - \delta \geq u(T_1, r) \quad \text{for } r \in [R_0, h(T_1)].$$

Therefore we can apply the comparison principle (see Lemma 3.2 of [7]) to conclude that

$$\bar{h}^\epsilon(t) \geq h(t), \quad \bar{u}^\epsilon(t, r) \geq u(t, r) \quad \text{for } r \in [R_0, h(t)], \quad t \geq T_1.$$

The proof is now complete. \square

Next we investigate the dependence of the spreading speed on the parameter μ . To stress this dependence, we will write $T = T(\mu)$ and $C(\mu) = L/T(\mu)$. We will prove the following result.

Theorem 4.2. $C(\mu)$ is strictly increasing in μ , and $\lim_{\mu \rightarrow \infty} C(\mu)$ exists and equals c_* , which is the minimal speed of the pulsating fronts for (1.4) obtained in [5].

The proof of this theorem is broken into several lemmas.

Lemma 4.3. Suppose that $0 < \mu_1 < \mu_2$. Then $C(\mu_1) < C(\mu_2)$.

Proof. Let (u_1, h_1) and (u_2, h_2) be the unique solutions of (1.1) with $\mu = \mu_1$ and μ_2 , respectively. Suppose that $h_1(\infty) = \infty$. By Theorem 3.5 of [8], we see that $h_1(t) \leq h_2(t)$ for $t > 0$. It follows from Theorem 4.1 that $C(\mu_1) \leq C(\mu_2)$.

It remains to show $C(\mu_1) \neq C(\mu_2)$. Let (u^1, h^1) and (u^2, h^2) be pulsating semi-waves corresponding to (μ_1, h_1) and (μ_2, h_2) respectively. By [Theorem 4.1](#),

$$\lim_{t \rightarrow \infty} \frac{h^i(t)}{t} = C(\mu_i), \quad i = 1, 2.$$

Arguing indirectly we suppose that $C(\mu_1) = C(\mu_2)$; we are going to deduce a contradiction. We follow the argument in the proof of [Theorem 3.1](#). As in Step 1 there, our assumption implies that $\tilde{h}(t) := h^1(t) - h^2(t)$ is a T -periodic function satisfying $\tilde{h}(0) = \tilde{h}(T) = 0$. If $\tilde{h} \equiv 0$, then $\tilde{u}^1 \equiv \tilde{u}^2$ and

$$\frac{d}{dt}h^1(t) = -\mu_1 u_x^1(t, h^1(t)) \equiv -\mu_1 u_x^2(t, h^2(t)) = \frac{\mu_1}{\mu_2} \frac{d}{dt}h^2(t) < \frac{d}{dt}h^2(t),$$

which is a contradiction.

If $\tilde{h} \not\equiv 0$, then as in Step 1 of the proof of [Theorem 3.1](#), we can shift t in $h^2(t)$ so that, after the shift,

$$h^1(t) \leq h^2(t) \quad \forall t \in \mathbb{R}, \quad h^1(t_0 + nT) = h^2(t_0 + nT), \quad n = 0, \pm 1, \pm 2, \dots$$

It follows that

$$\frac{d}{dt}h^1(t_0 + nT) = \frac{d}{dt}h^2(t_0 + nT).$$

On the other hand, if we define

$$W(t, x) = u^2(t, x) - u^1(t, x) \quad \text{for } (t, x) \in D := \{(t, x) : t \in \mathbb{R}, x < h^1(t)\},$$

then the same arguments as in the proof of [Theorem 3.1](#) yield

$$W(t, x) > 0 \quad \text{in } D \quad \text{and} \quad W_x(t_0, h^1(t_0)) < 0.$$

It follows that

$$u_x^1(t_0, h^1(t_0)) > u_x^2(t_0, h^2(t_0)),$$

or equivalently

$$-\mu_1^{-1} \frac{d}{dt}h^1(t_0) > -\mu_2^{-1} \frac{d}{dt}h^2(t_0),$$

which implies, due to $\mu_1 < \mu_2$,

$$\frac{d}{dt}h^1(t_0) < \frac{d}{dt}h^2(t_0).$$

Again we reach a contradiction.

Since every possibility leads to a contradiction, we conclude that $C(\mu_1) \neq C(\mu_2)$. \square

Lemma 4.4. *Suppose that $0 < \mu_1 < \mu_2$, and (u^1, h^1) , (u^2, h^2) are the unique pulsating semi-waves of (1.3) with $\mu = \mu_1, \mu_2$, respectively, which are normalized by $h^1(0) = h^2(0) = 0$. Then $h^1(t) < h^2(t)$ for $t > 0$ and $h^1(t) > h^2(t)$ for $t < 0$.*

Proof. From the previous lemma we find that

$$\lim_{t \rightarrow \infty} \frac{h^1(t)}{t} < \lim_{t \rightarrow \infty} \frac{h^2(t)}{t}.$$

Hence $0 < h^1(t) < h^2(t)$ for all large positive t , and $0 > h^1(t) > h^2(t)$ for all large negative t . Therefore there exists a smallest $t_0 \geq 0$ such that $h^1(t_0) = h^2(t_0)$ and $h^1(t) < h^2(t)$ for $t > t_0$. We show that $t_0 = 0$. Otherwise $t_0 > 0$ and due to $h^1(0) = h^2(0) = 0$, $C_0 := \max_{t \in [0, t_0]} \tilde{h}(t) \geq 0$, where $\tilde{h}(t) := h^1(t) - h^2(t)$. If $C_0 = 0$ then clearly $\frac{d}{dt}h^1(t_0) = \frac{d}{dt}h^2(t_0)$. If $C_0 > 0$ then we can shift t in $h^2(t)$ suitably to guarantee that for the shifted h^2 , still denoted by $h^2(t)$, and some new $t_0 > 0$, one has $h^1(t) < h^2(t)$ for $t > t_0$ and $h^1(t) \leq h^2(t)$ for $t \in [0, t_0]$. Hence again we have

$$\frac{d}{dt}h^1(t_0) = \frac{d}{dt}h^2(t_0), \quad h^1(t_0) = h^2(t_0), \quad h^1(t) \leq h^2(t) \text{ for } t \geq 0, \tag{4.7}$$

with strict inequality holding for $t > t_0$.

Define

$$W(t, x) = u^2(t, x) - u^1(t, x) \quad \text{for } (t, x) \in D := \{(t, x) : t > 0, x < h^1(t)\}.$$

Then we can argue as in the proof of [Theorem 3.1](#) to conclude that

$$W > 0 \quad \text{in } D \quad \text{and} \quad W_x(t_0, h^1(t_0)) < 0.$$

It follows that

$$\frac{d}{dt}h^1(t_0) = -\mu_1 u_x^1(t_0, h^1(t_0)) < -\mu_1 u_x^2(t_0, h^2(t_0)) = \frac{\mu_1}{\mu_2} \frac{d}{dt}h^2(t_0) < \frac{d}{dt}h^2(t_0),$$

a contradiction to [\(4.7\)](#). This proves that $h^1(t) < h^2(t)$ for $t > 0$.

The proof for the fact that $h^1(t) > h^2(t)$ for $t < 0$ is similar, and we omit the details. \square

Set

$$\begin{aligned} \bar{\alpha} &:= \sup_{r \geq 0} \alpha(r), & \underline{\alpha} &:= \inf_{r \geq 0} \alpha(r), \\ \bar{\beta} &:= \sup_{r \geq 0} \beta(r), & \underline{\beta} &:= \inf_{r \geq 0} \beta(r). \end{aligned}$$

By [Propositions 2.1 and 2.2](#) in [\[6\]](#), for each $k \in (0, 2\sqrt{\bar{\alpha}d})$, the problem

$$-dV'' + kV' = V(\bar{\alpha} - \underline{\beta}V) \quad \text{in } (0, \infty), \quad V(0) = 0, \quad V(\infty) = \bar{\alpha}/\underline{\beta}$$

has a unique positive solution $V_k(x)$, and for each $\mu > 0$, there exists a unique $k_0 = k_0(\mu) \in (0, 2\sqrt{\bar{\alpha}d})$ such that $\mu V'_{k_0}(0) = k_0$. Moreover, $k_0(\mu)$ strictly increases to $2\sqrt{\bar{\alpha}d}$ as μ increases to ∞ .

Lemma 4.5. $C(\infty) := \lim_{\mu \rightarrow \infty} C(\mu) \leq 2\sqrt{\bar{\alpha}d}$.

Proof. Denote by (\bar{u}, \bar{h}) the unique solution of [\(1.1\)](#) with $(\alpha(r), \beta(r))$ replaced by $(\bar{\alpha}, \underline{\beta})$. Since the modified problem is set in a homogeneous environment, we could apply the result of [\[7\]](#) to conclude that

$$\lim_{t \rightarrow \infty} \frac{\bar{h}(t)}{t} = k_0(\mu) < 2\sqrt{\bar{\alpha}d},$$

for any $\mu > 0$.

By the comparison principle in [\[7\]](#), we deduce $h(t) \leq \bar{h}(t)$ and $u(t, r) \leq \bar{u}(t, r)$ for $t > 0$ and $r \in [0, h(t)]$. It follows that $C(\mu) \leq k_0(\mu) < 2\sqrt{\bar{\alpha}d}$ for all $\mu > 0$. Therefore $C(\infty) = \lim_{\mu \rightarrow \infty} C(\mu) \leq 2\sqrt{\bar{\alpha}d}$. \square

Lemma 4.6. Let (u^μ, h^μ) be the unique normalized pulsating semi-wave of [\(1.3\)](#). Then

$$\frac{d}{dt}h^\mu(t) \leq k_0(\mu + 1) < 2\sqrt{\bar{\alpha}d} \quad \text{for all } t \in \mathbb{R}.$$

Proof. Fix an arbitrary $s_0 \in \mathbb{R}$. We show that there exists $t_0 \in \mathbb{R}$ such that

$$h^\mu(s_0) = k_0(\mu + 1)s_0 + t_0, \quad h^\mu(t) < k_0(\mu + 1)t + t_0 \quad \text{for } t > s_0. \tag{4.8}$$

Clearly this implies

$$\frac{d}{dt}h^\mu(s_0) \leq k_0(\mu + 1) < 2\sqrt{\bar{\alpha}d}.$$

Thus it suffices to prove [\(4.8\)](#).

Since

$$\lim_{t \rightarrow \pm\infty} \frac{h^\mu(t)}{t} = C(\mu) \leq k_0(\mu) < k_0(\mu + 1), \tag{4.9}$$

we have, for any $t_0 \in \mathbb{R}$,

$$h^\mu(t) < k_0(\mu + 1)t + t_0 \quad \text{for all large positive } t,$$

$$h^\mu(t) > k_0(\mu + 1)t + t_0 \quad \text{for all large negative } t.$$

Therefore there exists a minimal $s = s(t_0) \in \mathbb{R}$ such that

$$h^\mu(s) = k_0(\mu + 1)s + t_0, \quad h^\mu(t) \leq k_0(\mu + 1)t + t_0 \quad \forall t > s.$$

We claim that strictly inequality holds, namely

$$h^\mu(t) < k_0(\mu + 1)t + t_0 \quad \forall t > s.$$

Otherwise there exists $s_1 > s$ such that $h^\mu(s_1) = k_0(\mu + 1)s_1 + t_0$. It then follows that

$$\frac{d}{dt}h^\mu(s_1) = k_0(\mu + 1). \tag{4.10}$$

Define $D := \{(t, x) : t > s, x < h^\mu(t)\}$ and

$$\hat{u}(t, x) = V_{k_0(\mu+1)}(\hat{h}(t) - x), \quad \hat{h}(t) = k_0(\mu + 1)t + t_0.$$

We note that

$$\hat{u}_x(t, \hat{h}(t)) = -V'_{k_0(\mu+1)}(0) < 0,$$

and $u_x^\mu(t, h^\mu(t))$ is negative and periodic in t . Moreover,

$$\lim_{\hat{h}(t)-x \rightarrow \infty} \hat{u}(t, x) = \bar{\alpha}/\underline{\beta}, \quad \lim_{h^\mu(t)-x \rightarrow \infty} [u^\mu(t, x) - \phi(x)] = 0, \tag{4.11}$$

where $\phi(x)$ is the unique positive solution of $-d\phi'' = \phi[a(x) - b(x)\phi]$ in \mathbb{R} , and the limits are uniform. Moreover

$$\underline{\alpha}/\bar{\beta} \leq \phi(x) \leq \bar{\alpha}/\underline{\beta}.$$

Therefore there exists $c_0 > 0$ such that

$$\hat{u}(t, x) \geq c_0 u^\mu(t, x) \quad \text{in } D.$$

Taking the limits along $h^\mu(t) - x \rightarrow \infty$ we deduce

$$c_0 \underline{\alpha}/\bar{\beta} \leq c_0 \phi(x) \leq \bar{\alpha}/\underline{\beta}.$$

Hence $c_0 \leq \frac{\bar{\alpha}\bar{\beta}}{\underline{\alpha}\underline{\beta}}$. Define

$$c^* := \sup\{c > 0 : \hat{u}(t, x) \geq cu^\mu(t, x) \text{ in } D\}.$$

Then

$$c_0 \leq c^* \leq \frac{\bar{\alpha}\bar{\beta}}{\underline{\alpha}\underline{\beta}}, \quad \text{and } \hat{u} \geq c^* u^\mu \quad \text{in } D.$$

We show that $c^* \geq 1$. Otherwise $c^* < 1$ and for any positive sequence $\epsilon_n \rightarrow 0$, there exists $(t_n, x_n) \in D$ such that

$$\hat{u}(t_n, x_n) \leq (c^* + \epsilon_n)u^\mu(t_n, x_n), \quad n = 1, 2, \dots$$

Using (4.11) we easily see that $\{t_n\}$ and $\{x_n\}$ are bounded sets in \mathbb{R} . We may then argue as in Step 3 of the proof of [Theorem 3.1](#) to reach a contradiction.

Hence $c^* \geq 1$ and

$$W(t, x) := \hat{u}(t, x) - u^\mu(t, x) \geq 0 \quad \text{in } D, \quad W(s_1, h^\mu(s_1)) = 0.$$

From the equations for \hat{u} and u^μ we see that W satisfies, for some bounded function $c(t, x)$,

$$W_t - dW_{xx} + c(t, x)W \geq 0 \quad \text{in } D.$$

Hence we can apply the strong maximum principle and the Hopf lemma to conclude that

$$W > 0 \quad \text{in } D \text{ with } W_x(s_1, h^\mu(s_1)) < 0.$$

It follows that

$$\frac{d}{dt}h^\mu(s_1) = -\mu u_x^\mu(s_1, h^\mu(s_1)) < \mu V'_{k_0(\mu+1)}(0) < (\mu + 1)V'_{k_0(\mu+1)}(0) = k_0(\mu + 1).$$

But this contradicts (4.10). This proves our claim.

We now examine how $s(t_0)$ varies with t_0 . The property of $s(t_0)$ proved in the above claim implies that it varies continuously with $t_0 \in \mathbb{R}$. By (4.9), we see that

$$\lim_{t_0 \rightarrow +\infty} s(t_0) = -\infty, \quad \lim_{t_0 \rightarrow -\infty} s(t_0) = +\infty.$$

Hence for each $s_0 \in \mathbb{R}$, there exists t_0 such that $s(t_0) = s_0$. The conclusions in (4.8) now follow from the claim. \square

Lemma 4.7. $C(\infty) = c_*$.

Proof. Let $\{\mu_n\}$ be an increasing sequence converging to ∞ as $n \rightarrow \infty$. To simplify notations we write (u^n, h^n) for the unique normalized pulsating semi-wave (u^{μ_n}, h^{μ_n}) of (1.3) with $\mu = \mu_n$, and denote by $(U^n(\tau, \xi), p^n(\tau))$ the corresponding pair of $(u^n(t, x), h^n(t))$.

Making use of Lemma 4.6 and $p^n(h^n(t)) = \frac{d}{dt}h^n(t)$, we obtain $p^n(\tau) < 2\sqrt{\alpha d}$ for all $\tau \in \mathbb{R}$ and $n \geq 1$. Moreover, since $\{\mu_n\}$ is increasing, by Lemma 4.4 and using suitable shifts, it is easily seen that if $h^n(t) = h^{n+1}(t')$, then $\frac{d}{dt}h^n(t) \leq \frac{d}{dt}h^{n+1}(t')$. It follows that $p^n(\tau) \leq p^{n+1}(\tau)$ for all $\tau \in \mathbb{R}$. Therefore we may assume that $p^n \rightarrow p^*$ with

$$p^1(\tau) \leq p^*(\tau) \leq 2\sqrt{\alpha d}, \quad p^*(\tau) = p^*(\tau + L) \quad \forall \tau \in \mathbb{R}.$$

As in the proof of Theorem 3.4, by a simple comparison consideration we see that $\{U^n\}$ is a bounded set in $L^\infty(\mathbb{R} \times [0, \infty))$. Therefore we may apply the L^p theory for parabolic equations to the equation of U^n , much as in the proof of Theorem 3.4, to conclude that, by passing to a subsequence, $U^n \rightarrow U^*$ in $C_{loc}^{\frac{p+1}{2}, p+1}([0, L] \times [0, \infty))$, and (U^*, p^*) satisfies

$$p^*(\tau)(U_\tau^* + U_\xi^*) - dU_{\xi\xi}^* = U^*[a(\tau - \xi) - b(\tau - \xi)U^*], \quad (\tau, \xi) \in \mathbb{R} \times [0, \infty),$$

$$U^*(\tau, 0) = 0, \quad \tau \in \mathbb{R}.$$

From the identity $p^n(\tau) = \mu_n U_\xi^n(\tau, 0)$, we deduce

$$U_\xi^*(\tau, 0) \equiv 0.$$

Since $U^* \geq 0$, the Hopf lemma infers that $U^* \equiv 0$.

We now examine the sequence $\{(u^n, h^n)\}$. Let us note that for any $t_0 \in \mathbb{R}$, $(u^n(t + t_0, x), h^n(t + t_0))$ is also a pulsating semi-wave to (1.3) with $\mu = \mu_n$. For fixed $n \geq 1$, since $u^n(0, 0) = 0$, $\lim_{t \rightarrow \infty} u^n(t, 0) = \phi(0) \geq \alpha/\beta$, and $u^n(t, x)$ is strictly increasing in t , for fixed $\zeta \in (0, \alpha/\beta)$, there exists a unique $t_n > 0$ such that $u^n(t_n, 0) = \zeta$. We now replace (u^n, h^n) by its shift $(u^n(t + t_n, x), h^n(t + t_n))$, and still denote it by (u^n, h^n) . Then clearly

$$u^n(0, 0) = \zeta > 0, \quad h^n(0) > 0 \quad \forall n \geq 1.$$

We claim that $t_n \rightarrow \infty$ as $n \rightarrow \infty$. Otherwise by passing to a subsequence we may assume that $t_n \rightarrow t^*$. Then from the boundedness of $\{\frac{d}{dt}h^n\}$ we conclude that, subject to a subsequence, $h^n \rightarrow h^*$ in $C_{loc}^\mu(\mathbb{R})$. Since $\|u_n\|_\infty = \|U^n\|_\infty$ has a bound independent of n , we may apply L^p theory to the equation of u^n to conclude that, by passing to a subsequence, $u^n \rightarrow u^*$ in $C_{loc}^{\frac{1+v}{2}, 1+v}(D)$, with $D = \{(t, x) : t \in \mathbb{R}, x < h^*(t)\}$. Moreover, we have $u^*(0, 0) = \zeta > 0$. On the other hand, by the discussion above for the corresponding pairs (U^n, p^n) , we must have $u^* \equiv 0$. This contradiction shows that $t_n \rightarrow \infty$, as claimed.

Clearly the above proved claim implies that $h^n(t) \rightarrow \infty$ as $n \rightarrow \infty$, uniformly for $t \in [-M, \infty)$ for every $M > 0$. We may now once more apply the L^p theory to the equation of u^n to conclude that, by passing to a subsequence, $u^n \rightarrow u^*$ in $C_{loc}^{\frac{1+v}{2}, 1+v}(R^2)$, with $u^*(0, 0) = \zeta > 0$. Moreover, u^* satisfies

$$u_t^* - du_{xx}^* = u^*[a(x) - b(x)u^*] \quad \text{for } (t, x) \in \mathbb{R}^2.$$

Recall that $\frac{d}{dt}h^n(t)$ is T_n -periodic, with $C(\mu_n) = L/T_n$, and $u^n(t + T_n, x) = u^n(t, x - L)$. Since $C(\mu_n) \rightarrow C(\infty)$, we obtain $T_n \rightarrow T^* := L/C(\infty)$. It follows that

$$u^*(t + T^*, x) = u^*(t, x - L) \quad \text{for all } (t, x) \in \mathbb{R}^2. \tag{4.12}$$

Due to $u_t^n(t, x) > 0$, we obtain $u_t^*(t, x) \geq 0$. By the strong maximum principle, we easily see that either $u_t^* > 0$ or $u_t^* \equiv 0$. If $u_t^* \equiv 0$, then necessarily $u^*(t, x) = \phi(x)$. But we have $u^*(0, 0) = \zeta < \min \phi(x)$. Hence we necessarily have

$u_t^*(t, x) > 0$. From these properties of u^* we can now conclude that u^* is a pulsating front of (1.4). By (4.12), the speed of u^* is $C(\infty)$. Therefore we must have $C(\infty) \geq c_*$.

We show next that $C(\infty) \leq c_*$. For this purpose, we consider the auxiliary one-dimensional free boundary problem

$$\begin{cases} u_t - du_{xx} = u[a(x) - b(x)u], & t > 0, x \in (g(t), h(t)), \\ u(t, g(t)) = 0, \quad g'(t) = -\mu u_x(t, g(t)), & t > 0, \\ u(t, h(t)) = 0, \quad h'(t) = -\mu u_x(t, h(t)), & t > 0, \\ -g(0) = h(0) = h_0, \quad u(0, x) = u_0(x), & x \in [-h_0, h_0]. \end{cases} \quad (4.13)$$

Comparing (4.13) with the same problem where $(a(x), b(x))$ is replaced by the constant pair $(\min a(x), \max b(x))$, one easily sees from [10] that for all large $\mu > 0$, spreading occurs for (4.13). Moreover, a similar (but easier) analysis to that of Theorem 4.12 shows that

$$\lim_{t \rightarrow \infty} \frac{-g(t)}{t} = \lim_{t \rightarrow \infty} \frac{h(t)}{t} = C(\mu).$$

Let $\hat{u}(t, x)$ be the unique solution of the corresponding Cauchy problem to (4.13). Then by the comparison principle we have $u(t, x) < \hat{u}(t, x)$, which implies that $C(\mu)$ is no bigger than the spreading speed determined by this Cauchy problem. By [2] the spreading speed determined by this Cauchy problem is the minimal speed of the pulsating fronts of (1.4), namely c_* . Therefore we have $C(\mu) \leq c_*$. It follows that $C(\infty) \leq c_*$. \square
