# Propagation of analyticity of solutions to the Cauchy problem for Kirchhoff type equations

#### Abstract

We shall give the local in time existence of the solutions in Gevrey classes to the Cauchy problem for Kirhhoff equations of p-Laplacian type and investigate the propagation of analyticity of solutions for real analytic deta. When $\mathrm{p}=2$, his equation as the global real analytic solution for the real analytic initial data.


## 1. Introduction

In [6] we have obtained the local existence theorem in Gevrey class of solutions to the Cauchy problem for Kirchhoff equations of p-Laplacian type

where $\Delta_{p}$ is defined by

In this note we shall investigate the popagation of analyticity of solutions of the following Cauchy problem which is a generalization of (1.1),

u(0, x)=u_{0}(x), \quad u_{t}(0, x)=u_{1}(x), \quad x \in R^{n} \tag{1.4}
\end{gather*}
$$

where

A[u]=\sum_{j, k=1}^{n} \partial_{x_{j}}\left\{a_{j k}\left(x, \nabla_{x} u(t)\right) \partial_{x_{k}} u(t, x)\right\} \tag{1.5}
\end{equation*}
$$

and $M$ is a non negative two times continuous differentiable function defined in $[0, \infty)$ and $\left[a_{j k}(x, y)\right]$ is a non negative symmetric matrix of which elements are real valued functions defined in $R^{n} \times R^{n}$ and satisfies

for $x, \xi \in R^{n}, y \in R^{n}$. This assumption (1.6) assures that the equation (1.3) is hyperbolic. We can see easily that p -Laplacian $\Delta_{p}$ is verifies with the condition (1.6). Moreover we assume that the coefficients $\left\{a_{j k}\right\}$ satisfy that for a compact set $K$ in $R^{n}$ there are $C_{K}, \rho_{K}>0$ such that

for $x \in R^{n}, y \in K$. We introduce a functional space as follows,

where $\hat{u}$ stands for a Fourier transform of $u$ and $l \in R^{1}, d \geq 1,\langle\xi\rangle_{h}=\sqrt{h^{2}+|\xi|^{2}}$ and $\rho \geq 0$ and denote by $H^{l}=H_{0, d}^{l}$ and $L_{\rho, d}^{2}=H_{\rho, d}^{0}$. Now we begin to state a local existence theorem for the Cauchy problem (1.3)-(1.4).

Theorem 1.1 Assume that $M(\eta) \geq 0$ is in $C^{2}([0, \infty))$, (1.6) is valid, $a_{j k}$ satisfy (1.7) and there is $\rho_{0}>0$ such that the initial data $u_{0}, u_{1}$ belong to $L_{\rho_{0}, d}^{2}$ and $f \in$ $C^{0}\left(\left[0, T_{0}\right] ; L_{\rho_{0}, d}^{2}\right)$. Then if $s \leq d<2$ there are $T_{0}>T>0$ and $\rho_{1}>0$ such that the Cauchy problem (1.3) and (1.4) has a unique solution $u$ in $C^{2}\left([0, T] ; L_{\rho_{1}, d}^{2}\right)$.

It is well known that when $p=2$ and $d=1$, the Cauchy problem (1.1) and (1.4) has a global real analytic solution. For example see the article of Bernstein [2] and of Pohozaev [9]. When $M(\eta) \equiv 1$, Theorem 1,1 is proved in [3]. In [7] we proved that Thorem 1,1 holds for (1.1) and (1.4) under the assumption $s \leq d<4 / 3$. Moreover we can investigate the propagation of analyticity of solutions (1.3) and (1.4).

Theorem 1.2 Let $T>0$ a positive number. Assume $M(\eta) \geq 0$ is in $C^{2}([0, \infty))$, (1.6) and (1.7) with $s=1$ are valid and there are $\rho_{1}>0,1<d<2$ such that a function $u \in C^{2}\left([0, T] ; L_{\rho_{1}, d}^{2}\right)$ satisfies (1.3) and (1.4). Then if there is $\rho_{0}>0$ such that the initial data $u_{0}, u_{1}$ belong to $L_{\rho_{0}, 1}^{2}$ and $f \in C^{0}\left(\left[0, T_{0}\right] ; L_{\rho_{0}, 1}^{2}\right)$, we have $\rho_{2}>0$ such that $u$ belongs to $C^{2}\left([0, T] ; L_{\rho_{2}, 1}^{2}\right)$, that is, $u(t, x)$ is real analytic in a space variable $x$ for any $t \in[0, T]$.

## 2. A priori estimates for linearized equations

We shall derive a priori estimate in Gevrey class $H_{\rho, d}^{m}\left(R^{n}\right)$ for the linearized second order hyperbolic equations of equation (1.3). For $m, \rho, \delta \in R(0 \leq \delta \leq \rho \leq 1)$ denote by $S_{\rho, \delta}^{m}$ the usual symbol class of oder $m$ of $\rho, \delta$ type. For simplicity we write $S^{m}=S_{1,0}^{m}$ and introduce the seminorms as follows,

where $\langle\xi\rangle_{h}=\left(h^{2}+|\xi|^{2}\right)^{\frac{1}{2}}(h>0$ is a large parameter). For $d \geq 1, \rho>0$ and $m \in R$ we define the symbols of Gevrey class $\gamma_{\rho}^{d} S^{m}$. We say that a symbol $a \in S^{m}$ belongs to $\gamma_{\rho}^{d} S^{m}$, if $a$ satisfies

Define for $\rho \in R$

e^{\rho<D>_{h}^{1 / d}} u(x)=(2 \pi)^{-n} \int e^{i x \xi+\rho(\xi)_{h}^{1 / d}} \hat{u}(\xi) d \xi

for $u \in H_{\rho, d}^{m}$. Then $e^{\rho<D>_{h}^{1 / d}}$ maps from $H_{\rho_{1}, d}^{m}$ to $H_{\rho_{1}-\rho, d}^{m}$ continuously. Moreover for $a \in \gamma_{\rho_{0}}^{d} S^{m_{1}}$ we can see that $a(x, D)$ maps from $H_{\rho, d}^{m}$ to $H_{\rho, d}^{m+m_{1}}$ continuously if $|\rho| \leq\left(24 n^{\kappa}\right)^{-1} \rho_{0}^{\kappa}, \kappa=1 / d$ and consequently

maps $H^{m}$ to $H^{m+m_{1}}$ continuously, where $H^{m}=\left\{u \in \mathcal{S}^{\prime}\left(R^{n}\right) ;\langle\xi\rangle_{h}^{m} \hat{u}(\xi) \in L^{2}\left(R^{n}\right)\right\}$ is the usual Sobolev space. Moreover we can prove the following Lemma.

Lemma 2.1 Let $d>1, \rho \in R, \kappa=1 / d$ and $a \in \gamma_{\rho_{0}}^{d} S^{m}$. Then the symbol of $a(\rho, x, D)$ given by (2.3) belongs to $S^{m}$ and satisfies for any integer $N \geq 0$,

and the remainder term $r_{N}(a)(\rho, x, \xi)$ belongs to $S^{m-N(1-1 / d)}$ and moreover there are $C_{N}$ independent of such that for $h \geq 1$

The proof of this lemma is given in Lemma 1.2 of [3]. We can prove the following lemma by use of the above lemma.

Lemma 2.2 (i) Let $a \in S^{0}$. Then there is a positive integer $l_{0}$ such that

for $u \in L_{2}$.
(ii) Let $a \in \gamma_{\rho_{0}}^{d} S^{m}$ and $\Lambda=\rho\langle\xi\rangle_{h}^{\kappa}$. Then if $|\rho| \leq\left(24^{d} n\right)^{-\kappa} \rho_{0}^{\kappa}$,

for $u \in H^{s+m}$, where $l_{1}=|s|+M\left(l_{0}\right)$.
We shall derive a priori estimates for a linear equation below

Assume that the principal part $a(t, x, \xi)$ and $b(t, x, \xi)$ satisfy

Then the non-negativity of $a$ implies

for $(t, x, \xi) \in\left[0, T_{0}\right] \times R^{2 n}$. Put

where $\Lambda(t, \xi)=\rho(t)\langle\xi\rangle_{h}^{\kappa}$. Then $v$ satisfies

where for an operator $a$ we denote by $a_{\Lambda}$ the product $e^{\Lambda} a e^{-\Lambda}$. Introduce an energy of $v$ below

where $\kappa=1 / d,\|\cdot\|_{s}$ and $(\cdot, \cdot)_{s}$ mean a norm and an inner product of Sobolev space $H^{s}$ respectively.

Proposition 2.1 Assume (2.9), (2.10) and (2.11) are valid and $v \in \bigcap_{j=0}^{2} C^{2}\left(\left[0, T_{0}\right]\right.$; $H^{s-j}$ ). For any $s \in R$ there are a positive constant $C_{s}, h_{s}$ and a positive function $\rho(t) \in C^{2}\left(\left[0, T_{0}\right]\right.$ such that

for $t \in\left[0, T_{0}\right]$ and $h \geq h_{s}$.
Proof. Differentiating $e_{s}(t)^{2}$ in $t$, we have

\left.+\left(\left(a(t)+a^{*}(t)\right) \Lambda_{t} v, v\right)_{s}+\left(\partial_{t}-\Lambda_{t}\right) v, v\right)_{s+\kappa}+\left(\Lambda_{t} v, v\right)_{s+\kappa} \\
=\Re\left(-\left(a_{\Lambda}(t)+b_{\Lambda}\right) v+L_{\Lambda}[v]+\Re a(t) v,\left(\partial_{t}-\Lambda_{t}\right) v\right)_{s}+\left(\Lambda_{t}\left(\partial_{t}-\Lambda_{t}\right) v,\left(\partial_{t}-\Lambda_{t}\right) v\right)_{s} \\
+\frac{1}{2} \Re\left(a_{t}(t) v, v\right)_{s}+\left(\left(a(t)+a^{*}(t)\right)\left(\partial_{t}-\Lambda_{t}\right) v, v\right)_{s}
\end{gathered}
$$

+\left(\left(\Lambda_{t}\left(a(t)+a^{*}(t)\right) \Lambda_{t} v, v\right)_{s}+\left(\partial_{t}-\Lambda_{t}\right) v, v\right)_{s+\kappa}+\left(\Lambda_{t} v, v\right)_{s+\kappa} \tag{2.19}

Noting that from Lemma 1.1 we have

+\frac{1}{8}\left|\left\|\left.\Lambda_{t}\right|^{\frac{1}{2}}\left(\partial_{t}-\Lambda_{t}\right) v\right\|_{s}^{2}\right.
\end{gather*}

Since $r \in S^{2 \kappa}$, and $\Lambda_{t}=\rho_{t}(t)\langle\xi\rangle_{h}^{\kappa}$, we can see

where $r \in C^{0}\left(\left[0, T_{0}\right] ; S^{1}\right)$. From $(2,12)$ and (2.21) we have

It follows from (4.4) that taking $T>0$ such that $C(M) T \leq 1$, we get

$$
\begin{equation*}
\left\|\partial_{t}^{2} u(t)\right\|_{H_{\rho_{1}, d}^{l-2}}+\left\|\partial_{t} u(t)\right\|_{H_{\rho_{1}, d}^{l-1}}+\|u(t)\|_{H_{\rho_{1}, d}^{l}} \leq e\left(C_{0}+1\right), \quad t \in[0, T] . \tag{4.5}
\end{equation*}
$$

For $a \in B(T, M)$ denote by $u_{a}$ the solution of (4.2)-(4.3). Define

$$
\begin{equation*}
\Psi(a)(t)=\left(A\left[u_{a}\right], u_{a}\right)_{L^{2}}=\sum\left(a_{j k}\left(x, \nabla_{x} u_{a}\right) D_{k} u_{a}, D j u_{a}\right)_{L^{2}} . \tag{4.6}
\end{equation*}
$$

By use of the above proposition we can prove similarly to Proposition 2.1 in [6] that $\Psi$ is a contraction mapping in $B(M, T)$, if $M, T$ are chosen suitably.

## 5. Proof of Theorem 1.2

To investigate the analyticity of solutions to the Cauchy problem (1,3)-(1.4), we introduce a convinient norm in $C^{0}\left([0, T] ; L_{\rho_{0}, d}^{2}\left(R^{n}\right)\right)$ following the idea of Lax [7], Mizohata [8] and Alnihac and Métivier [1]. Let a positive integer $N \geq 2, \rho>0$, and $0<r \leq 1$. For $e^{\Lambda} u \in C^{0}\left([0, T] ; H^{l}\right)$, where $\Lambda=\Lambda(t, \rho)=(\rho(t)+\rho)\langle\xi\rangle_{h}^{\kappa}, 0<\rho<$ $\rho_{0} / 2=: \rho_{2}$ is given in Proposition 2.1, we denote

$$
\begin{equation*}
|u|_{\rho, r, N}^{t}=\sup _{0<s<t, 2 \leq|\beta| \leq N} \frac{\left\|e^{\Lambda(s, \rho)} D_{x}^{\beta} u\right\|_{\mid} r^{|\beta|-2}}{\Gamma_{2}(|\beta|)}, \tag{5.1}
\end{equation*}
$$

where $\Gamma_{2}(k)=\lambda_{0} k!k^{-2}$ for $k \geq 1$ and $\Gamma_{2}(0)=\lambda_{0}$. Here we choose $\lambda_{0}>0$ such that

$$
\begin{equation*}
\sum_{\alpha^{\prime} \leq \alpha}\binom{\alpha}{\alpha^{\prime}} \Gamma_{2}\left(\left|\alpha^{\prime}\right|+p\right) \Gamma_{2}\left(\left|\alpha-\alpha^{\prime}\right|\right) \leq \Gamma_{2}(|\alpha|+p) \tag{5.2}
\end{equation*}
$$

for $p=0,1,2, \ldots$ and $\alpha \in N^{n}$. In brief we write $|u|_{r, N}=|u|_{\rho, r, N}^{t}$, if there is no confusion.

Lemma 5.1 For $e^{\Lambda} v_{i} \in C^{0}\left(\left[t_{0}, T\right] ; H^{l}\right), i=1, \ldots, n$, denote $v^{\beta}=v_{1}^{\beta_{1}} v_{2}^{\beta_{2}} \cdots v_{n}^{\beta_{n}}$. Then there is $C_{0}>0$ such that for $2 \leq|\beta| \leq N, t \in[0, T]$,

$$
\begin{equation*}
\left|v^{\beta}\right|_{r, N} \leq C_{0}^{|\beta|-1}\left(\sup _{t_{0} \leq s \leq t}\left\|e^{\Lambda} v(s)\right\|_{l+1}+r^{2}|v|_{r, N}\right)^{|\beta|-1}|v|_{r, N} \tag{i}
\end{equation*}
$$

and for $|\beta|>N, t \in[0, T]$

$$
\begin{align*}
\left|v^{\beta}\right|_{r, N} \leq C_{0}^{|\beta|-1}\left(\left\|e^{\Lambda} v(t)\right\|_{l}\right. & \left.+r^{2}\right)^{|\beta|-N}\left(\left(\left\|e^{\Lambda} v(s)\right\|_{l+1}+r^{2}|v|_{r, N}\right)^{N-1}|v|_{r, N}\right)  \tag{ii}\\
+ & C_{0}^{|\beta|}\left\|e^{\Lambda} v\right\|_{l+1}^{|\beta|} .
\end{align*}
$$

(iii) Let $a(x) \in \mathcal{A}\left(R^{n}\right)$ satisfying

$$
|a|_{R^{n}, \rho_{1}, 1}=\sup _{\beta \in N^{n}, x \in R^{n}} \frac{\left|D_{x}^{\beta} a(x)\right| \rho_{0}^{|\beta|}}{|\beta|!}<\infty .
$$

Then there is $C>0$ such that for $|\rho(t)+\rho| \leq\left(24 n^{\kappa}\right)^{-1} \rho_{1}^{\kappa}$,

$$
|a v|_{r, N} \leq C|a|_{R^{n}, \rho_{1}, 1}|v|_{r, N} .
$$

(iv) Let $G$ an open set in $R^{N}$ and $A(x, v)$ is analytic in $R^{n} \times G$ and satisfies

$$
|A|_{R^{n} \times G, \rho_{1}, 1}=\sup _{\alpha, \beta \in N^{n}, x \in R^{n}, v \in G} \frac{\left|D_{x}^{\alpha} D_{v}^{\beta} A(x, v)\right| \rho_{1}^{|\alpha|+|\beta|}}{|\alpha|!|\beta|!}<\infty
$$

Then if $\left\|e^{\Lambda} v(t)\right\|_{l+1}<\rho_{1} /\left(n C_{l}\right)$, a composite function $A \circ v(t, x)=A(x, v(t, x))$ satisfies that there is $C>0$ such that for $t \in[0, T]$

$$
|A \circ v|_{r, N} \leq C|A|_{R^{n} \times G, \rho_{0}, 1}\left(1+\sum_{j=0}^{N-1} C^{j}\left(\left\|\left.e^{\Lambda} v(s)\left|\|_{l+1}+r^{2}\right| v\right|_{r, N}\right)^{j}|v|_{r, N}\right) .\right.
$$

The proof of this lemma is given in [5]. We remark that it follows from (iv) of Lemma 5.1 that if $A(x, y)$ is analytic in $(x, y) \in R^{n} \times G$, and $\left\|e^{\Lambda} \nabla_{x} v(t)\right\|_{l+1}<$ $\rho_{1} /\left(n C_{l}\right)$, we have for $2 \leq|\alpha| \leq N$,

$$
\begin{gather*}
\left\|e^{\Lambda} D_{x}^{\alpha}\left(A \circ \nabla_{x} v\right)\right\|_{l} \leq C r^{-|\alpha|+2} \Gamma_{2}(|\alpha|+1)  \tag{5.3}\\
\times\left\{1+\sum_{j=0}^{N-1} C^{j}\left(\sup _{t_{0} \leq s \leq t}\|v(s)\|_{l+2}+r^{2}|v|_{r, N}\right)^{j}\left|\nabla_{x} v\right|_{r, N}\right\},
\end{gather*}
$$

where $C$ is independent of $N$.
Now we shall turn to prove Theorem 1.2. Let $u$ be satisfied with (1.3)-(1.4). Since $u \in C^{0}\left([0, T] ; H_{\rho_{0}}^{l}\right)$, for any $\epsilon>0$ there is $\tau>0$ such that for $\Lambda(t)=(\rho(t)+\rho)\langle\xi\rangle_{h}^{\kappa}$ satisfying (2.37)-(2.38),

$$
\begin{equation*}
\left\|e^{\Lambda}(t)(u(t, \cdot)-u(i \tau, \cdot))\right\|_{l+2}<\epsilon, \tag{5.4}
\end{equation*}
$$

for $t \in[i \tau,(i+1) \tau], i=0,1, \ldots,[T / \tau]$ and $t \in[[T / \tau] \tau, T]$, where $[\cdot]$ stands for the Gauss notation. Denote $\tau_{i}=i \tau$ for $i=0,1, \cdots,[T / \tau]$, and $\tau_{[T / \tau]+1}=T$. We shall prove that $u\left(\tau_{i}, x\right)$ is in $L_{\rho_{i}, 1}^{2}$ for $i=0,1, \ldots,[T / \tau]+1$ by induction of $i$. First it is trivial that $u(0, x)=u_{0}(x)$ is in $L_{\rho_{0}, 1}^{2}\left(R^{n}\right)$. Assume that $u\left(\tau_{i}, x\right)$ is in $L_{\rho_{i}, 1}^{2}\left(R^{n}\right)$. Then we show that $u\left(\tau_{i+1}, x\right)$ belongs to $L_{\rho_{i+1}}^{2}\left(R^{n}\right)$. Then we may assume that

$$
\begin{equation*}
\left\|e^{\Lambda} D_{x}^{\alpha} u\left(\tau_{i}, \cdot\right)\right\|_{l+2} \leq C r_{i}^{-|\alpha|}|\alpha|! \tag{5.5}
\end{equation*}
$$

For the simplicity of notation we consider the case of $i=0$. Put $v(t, x)=u(t, x)-$ $u_{0}(t, x)$, where $u_{0}(t, x)=u(0, x)+t u_{t}(0, x)$. Since $u$ is a solution of (1.3), $v$ satisfies

$$
\begin{gather*}
\partial_{t}^{2} v-\sum_{j, k=1}^{n} \tilde{a}_{j k}\left(t, x, \nabla_{x} v\right) D_{j} D_{k} v=\tilde{f}(t, x, v),(t, x) \in(0, \tau) \times R^{n},  \tag{5.6}\\
v(0, x)=v_{t}(0, x)=0, \quad x \in R^{n}, \tag{5.7}
\end{gather*}
$$

where

$$
\begin{gather*}
\tilde{a}_{j k}\left(t, x, \nabla_{x} v\right)=a_{j k}\left(t, x, \nabla_{x}\left(v+u_{0}(t, x)\right)\right)  \tag{5.8}\\
+\sum_{m=1}^{n} \partial_{y_{m}} a_{j m}\left(x, \nabla_{x}\left(v+u_{0}(t, x)\right) \partial_{x_{m}}\left(v\left(t, x+u_{0}(t, x)\right)\right.\right.
\end{gather*}
$$

and

$$
\begin{equation*}
\tilde{f}\left(t, x, \nabla_{x} v\right)=f(t, x)-\sum_{j, k=1}^{n} \tilde{a}_{j k}\left(t, x, \nabla_{x} v\right) D_{j} D_{k} u_{0}(t, x) \tag{5.9}
\end{equation*}
$$

Then it follows from (3.8) that $\tilde{A}_{j}$ and $\tilde{f}-f$ satisfy the condition of (iv) in Lemma 3.1. Therefore $\tilde{A}_{j}$ and $\tilde{f}-f$ satisfy (5.3). Differentiating (5.6) with respect to $x$ we get

$$
\begin{equation*}
L\left[D^{\alpha} v\right]=f_{\alpha}, \quad D^{\alpha} v(0, x)=D^{\alpha} v_{t}(0, x)=0 \tag{5.10}
\end{equation*}
$$

where

$$
\begin{equation*}
f_{\alpha}=D^{\alpha} \tilde{f}+\sum_{\alpha^{\prime}<\alpha}\binom{\alpha}{\alpha^{\prime}} \sum_{j, k=1}^{n} D^{\alpha-\alpha^{\prime}} \tilde{a}_{j k} D^{\alpha^{\prime}} D_{j} D_{k} v . \tag{5.11}
\end{equation*}
$$

Therefore by use of (2.39) of Proposiyion 2,3 we obtain

$$
\begin{gather*}
\left\|e^{\Lambda(t, \rho)} D^{\alpha} \nabla_{x} v(t)\right\|_{l} \leq C \int_{0}^{t}\left\|e^{\Lambda(s, \rho)} f_{\alpha}(s)\right\|_{l+1-\kappa} d s  \tag{5.12}\\
\leq C \int_{0}^{t}\left(\rho^{\prime}-\rho\right)^{-1}\left\|e^{\Lambda\left(s, \rho^{\prime}\right)} f_{\alpha}\right\|_{l} d s
\end{gather*}
$$

for $\rho^{\prime} \in\left(\rho, \rho_{2}\right)$. On the other hand from (5.2),(5.3) and (5.4) we have if in brief $\|\cdot\|=\left\|e^{\Lambda\left(s, \rho^{\prime}\right)} \cdot\right\|_{l}$,

$$
\begin{align*}
& \left\|f_{\alpha}(s)\right\| \leq\left\|D^{\alpha} \tilde{f}\right\|+\sum_{1 \leq\left|\alpha^{\prime}\right| \leq|\alpha|-1}\binom{\alpha}{\alpha^{\prime}} \sum_{j, k=1}^{n}\left(\left\|D^{\alpha-\alpha^{\prime}} \tilde{a}_{j k}\left|\|\left|\left|D^{\alpha^{\prime}} D_{j} D_{k} v\right|\right|\right)\right.\right.  \tag{5.13}\\
& \leq|f|_{r, N}^{s} r^{-|\alpha|+2} \Gamma_{2}(|\alpha|)+C \sum_{1 \leq\left|\alpha^{\prime}\right| \leq|\alpha|-2}\binom{\alpha}{\alpha^{\prime}} r^{-\left(\left|\alpha-\alpha^{\prime}\right|+2\right)} \Gamma_{2}\left(\left|\alpha-\alpha^{\prime}\right|\right) \\
& \times\left\{1+\sum_{j=0}^{N-1} C^{j}\left(\epsilon+r^{2}\left|\nabla_{x} v\right|_{r, N}^{s}\right)^{j}\left|\nabla_{x} v\right|_{r, N}^{t}\right\}\left|\nabla_{x} v\right|_{r, N}^{s} r^{-\left|\alpha^{\prime}\right|+1} \Gamma_{2}\left(\left|\alpha^{\prime}\right|+1\right) \\
& \leq\left\{|f|_{r, N}^{s} r^{-|\alpha|+2} \Gamma_{2}(|\alpha|)\right. \\
& +C\left\{1+\sum_{j=0}^{N-1} C^{j}\left(\epsilon+r^{2}\left|\nabla_{x} v\right|_{r, N}^{s}\right)^{j}\left|\nabla_{x} v\right|_{r, N}^{s}\right\}\left(r^{-|\alpha|+3}|v|_{r, N}^{s} \Gamma_{2}(|\alpha|+1) .\right.
\end{align*}
$$

Here we choose $r=r\left(s, \rho^{\prime}\right)=r_{0}\left(\sigma\left(\rho_{2}-\rho^{\prime}\right)-s\right)$, where $0<r_{0} \leq 1, \sigma=\frac{\tau}{\rho_{2}}$ and $0<\rho<\rho_{2}$. Denote

$$
y(t)=\sup _{0 \leq s \leq \min \left\{t, \sigma\left(\rho_{2}-\rho\right)\right\}, 0<\rho<\rho_{2}} r(s, \rho)|v|_{r(s, \rho), N}^{s} .
$$

We have from (5.13)

$$
\begin{gathered}
\left\|f_{\alpha}\right\| \leq|f|_{r, N}^{s} r\left(s, \rho^{\prime}\right)^{-|\alpha|+2} \Gamma_{2}(|\alpha|) \\
\left.+C\left\{r\left(s, \rho^{\prime}\right)+\sum_{j=0}^{N-1} C^{j}(\epsilon+y(s))^{j} y(s)\right\} y(s) r\left(s, \rho^{\prime}\right)^{-|\alpha|+1} \Gamma_{2}\right\}(|\alpha|+1)
\end{gathered}
$$

Hence we have from (5.12) and (5.13)

$$
\begin{aligned}
& \left\|e^{\Lambda} D^{\alpha} \nabla_{x} v(t)\right\|_{l} \leq C \int_{0}^{t}\left(\rho^{\prime}-\rho\right)^{-1}\left\{\left(|f|_{r, N}^{s} r(s)^{-|\alpha|+2} \Gamma_{2}(|\alpha|)\right.\right. \\
& \left.+C\left(r+\sum_{j=0}^{N-1} C^{j}(\epsilon+y(s))^{j} y(s)\right) y(s) r(s)^{-|\alpha|+1} \Gamma_{2}(|\alpha|+1)\right\} d s
\end{aligned}
$$

Here we take $\rho^{\prime}-\rho=r\left(s, \rho^{\prime}\right) r_{0}^{-1}=\sigma\left(\rho_{2}-\rho^{\prime}\right)-s$, that is $\rho^{\prime}=\frac{\tau+\rho-s}{1+\sigma}$. Then noting that $y(s) \leq y(t)$ for $s<t$ and $r\left(s, \rho^{\prime}\right) \leq r_{0} \tau \leq r_{0}$ we get from the above estimate

$$
\begin{align*}
& \left\|e^{:(t, \rho)} D^{\alpha} \nabla_{x} v(t)\right\|_{l} \leq|f|_{r, N}^{t} \int_{0}^{t} r_{0} r\left(s, \rho^{\prime}\right)^{-|\alpha|+1} d s \Gamma_{2}(|\alpha|)  \tag{5.14}\\
+ & C \int_{0}^{t}\left(r_{0}+\sum_{j=1}^{N} C^{j}(\epsilon+y(s))^{j} y(s) r_{0} r\left(s, \rho^{\prime}\right)^{-|\alpha|} d s \Gamma_{2}(|\alpha|+1) .\right.
\end{align*}
$$

Since $|f|_{r, N}^{t} \leq C, r(t) \leq r_{0} \tau \leq r_{0}$ and $r_{0} \int_{0}^{t} r(s)^{-|\alpha|} d s \leq r(t)^{-|\alpha|+1}|\alpha|^{-1}$ for $|\alpha| \geq 2$, we get from (5.14)

$$
\left.y(t) \leq C r_{0}\left\{1+\sum_{j=0}^{N} C^{j}(\epsilon+y(t))^{j} y(t)\right\}\right)
$$

for $t \in[0, \tau]$. We shall prove that $y(t)<\epsilon$ for $t \in[0, \tau]$, if we choose $r_{0}>0, \varepsilon>0$ small enough. Assume that there is $t_{1} \in[0, \tau]$ such that $y\left(t_{1}\right)=\epsilon$ and $y(t)<\epsilon$ for $t \in\left(0, t_{1}\right)$. Since $y(0)=0$, we have $t_{1}>0$. It follows from (5.15) that if $2 C \varepsilon<1$

$$
y(t) \leq C r_{0}\left(1+\frac{y(t)}{1-2 C \epsilon}\right)
$$

for $t \in\left[0, t_{1}\right]$. Hence we have

$$
y\left(t_{1}\right) \leq \frac{C r_{0}}{1-\frac{C r_{0}}{1-2 C \varepsilon}}<\varepsilon
$$

which contradicts to $y\left(t_{1}\right)=\varepsilon$ if we choose $r_{0}$ sufficient small, and consequently we have proved Theorem 3.
