# NUMERICAL METHODS FOR A MODEL FOR WAVE PROPAGATION IN COMPOSITE ANISOTROPIC MEDIA (*)

Abstract - The problem of wave propagation through an anisotropic system consusting of an elastic solid $\Omega_{s}$ containing a flutd-saturated porous medium $\Omega_{p}$ is considered. The partual differential equations chosen to describe the propagation are the usual elastic wave equation in $\Omega_{s}$ and Biot's low-frequency dynamic equatoons for $\Omega_{p}$, stated in terms of the global solvd displacement vector $u_{1}$ for $\Omega=\Omega_{s} \cup \Omega_{p}$ and the relatve vector movement $u_{2}$ between fluid and solid in $\Omega_{p}$

Energy flux preserving boundary condittons are used at the interface between $\Omega_{s}$ and $\Omega_{p}$, while absorbing boundary conditions, derived in the last Section of this work, are imposed at the artificial boundartes of $\Omega$

Since the solution $u=\left(u_{1}, u_{2}\right)$ of this wave problem is expected to lie in $\left[H^{1}(\Omega)\right]^{3} \times$ $H_{0}\left(\operatorname{div}, \Omega_{p}\right)$, standard finite element spaces are used to approximate the solvd displacement vector $u_{1}$, while the relative movement vector $u_{2}$ is approximated using mixed finite element subspaces of $H_{0}\left(\mathrm{~d} ı v, \Omega_{p}\right)$

Existence and uniqueness results as well as continuous and discrete-time finte element methods for the approximate solution of this wave problem are given and analyzed

Also, the case of particular interest in exploration geophysics in which $\Omega$ represents a twodimensional transverse antsotropic elastic system is analyzed in detail

Resume - On consıdère tct le problème de la propagation d'onde dans un système antsotrope composé d'un solıde élastıque $\Omega_{s}$ et d'un mılıeu poreux saturé de fluıde $\Omega_{p}$ Les équatıons aux dérıvées parttelles décrıvant la propagatıon de l'onde sont l'équatıon d'onde de l'élastıcıté lınéaire dans $\Omega_{s}$ et les equatıons de BIOT de dynamıque à basse fréquence pour $\Omega_{p}$, elles sont exprimées en fonction du vecteur déplacement $u_{1}$ pour $\Omega=\Omega_{s} \cup \Omega_{p}$ et du vecteur de déplacement relatif $u_{r} d u$ fluide par rapport au solvde dans $\Omega_{p}$

[^0]Comme la solution $u=\left(u_{1}, u_{2}\right)$ de ce problème d'onde appartient à $\left[H^{1}(\Omega)^{3}\right] \times H_{0}\left(\operatorname{div}, \Omega_{p}\right)$, des éléments finis standards sont utilisés pour l'approximation du vecteur déplacement dans le solide $u_{1}$, tandis que le vecteur de déplacement relatif $u_{2}$ est approximé dans des sous-espaces d'éléments finis mixtes de $H_{0}\left(\operatorname{div}, \Omega_{p}\right)$.

## 1. INTRODUCTION

We will consider the problem of wave propagation through a composite anisotropic system $\Omega$ consisting of an elastic solid $\Omega_{s}$ containing a porous medium $\Omega_{p}$ saturated by a compressible viscous fluid. The standard elastic wave equation and Biot's low-frequency dynamic equations are used to describe the propagation of waves in $\Omega_{s}$ and $\Omega_{p}$, respectively.

The validity of Biot's low-frequency dynamic equations in $\Omega_{p}$ implies that several physical assumptions are made. First, wave lengths have to be appreciably greater than the diameter of the pores. Also the fluid may flow relative to the solid causing friction to arise. Dissipation is assumed to depend only on such a relative movement between fluid and solid, which is supposed to take place according to Darcy's law of fluid flow through porous anisotropic media. Finally, the form of Biot's equations chosen in this work, which were presented in [5], allows us to consider domains $\Omega_{p}$ having non-uniform porosity.

Appropriate energy-preserving boundary conditions are imposed at the contact surface between $\Omega_{s}$ and $\Omega_{p}$. Also, absorbing boundary conditions for the artificial boundaries of the model are derived. These conditions are obtained from the conservation of momentum equations for anisotropic elastic solids and generalize those given in [12] for the isotropic case.

In a previous work [19], the problem considered here was treated for the isotropic case but using another form of Biot's equations which is valid only for uniform porosity [3]. Also, several earlier papers are related to the subject. Biot's theory of propagation of elastic waves in fluid-saturated anisotropic porous media will be strongly referred [4, 5]. The problem of existence and uniqueness of the solution of Biot's equations for isotropic media with uniform porosity as well as numerical methods for the approximate solution of such equations were considered in [17, 18]. Finite element methods for solving the elastic wave equation in isotropic media were presented in [16]. Boundary conditions allowing conservation of energy flux through the interface between $\Omega_{s}$ and $\Omega_{p}$ were first given in [11]. The organization of the paper is as follows. In Section 2 we describe the composite anisotropic model and state the partial differential equations as well as the initial and boundary conditions describing it. In Section 3 we present some notation and results to be used. In Section 4 we first derive the weak form of the problem and state the existence and uniqueness theorem
for the solution of the composite system. Then we present the finite element spaces to be used for the spatial discretization and formulate the continuous and discrete-time Galerkin procedures. Since the existence and uniqueness results and the error bounds for the numerical methods can be obtained by repeating the arguments given for the model treated in [19], all the theorems of this Section are stated without proof. In Section 5 we apply the results previously derived to the case of particular interest in exploration geophysics in which $\Omega$ is a two-dimensional transverse anisotropic composite system. Finally, in Section 6 we present the derivation of the absorbing boundary conditions for anisotropic elastic solids used in our model.

## 2. THE COMPOSITE ANISOTROPIC MODEL

Let us identify the composite anisotropic elastic system with an open bounded domain $\Omega \subset R^{3}$ and assume that its boundary, denoted by $\partial \Omega$, is Lipschitz continuous. Let $\Gamma_{0} \subset \partial \Omega$ and $\Gamma_{1}=\partial \Omega \backslash \Gamma_{0}$ be the stress-free and artificial boundaries of the model, respectively. It will be assumed that both $\Gamma_{0}$ and $\Gamma_{1}$ have strictly positive $d \sigma$-measure, $d \sigma$ being the surface measure on $\partial \Omega$. Let $\Omega_{p} \subset \subset \Omega$ and $\Omega_{s}=\Omega \backslash \bar{\Omega}_{p}$ be the fluid-saturated porous medium and elastic solid parts of $\Omega$, respectively, and set $\Gamma_{2}=\partial \Omega_{p}$, that will also be assumed to be Lipschitz continuous.

Let $u_{1}(x, t)=\left(u_{11}(x, t), u_{12}(x, t), u_{13}(x, t)\right)$ be the vector representing the displacement in the solid part of $\Omega$ (i.e. both in $\Omega_{s}$ and $\Omega_{p}$ ) and let $\tilde{u}_{2}(x, t)=\left(\tilde{u}_{21}(x, t), \tilde{u}_{22}(x, t), \tilde{u}_{23}(x, t)\right)$ be the locally averaged fluid displacement in $\Omega_{p}$. Here $u_{1 i}$ and $\tilde{u}_{2 i}$ are the displacement in the $x_{i}$-direction for $1 \leqslant i \leqslant 3$. The $\tilde{u}_{2 i}$ 's are defined so that the volume of fluid displaced through a unit area $S$ normal to the $x_{i}$-direction is $\int_{S} \phi \tilde{u}_{2 i} d \sigma$, $\phi=\phi(x)$ being the effective porosity.

Let $\quad u_{2}(x, t)=\phi(x)\left(\tilde{u}_{2}(x, t)-u_{1}(x, t)\right)=\left(u_{21}, u_{22}, u_{23}\right) \quad$ and set $u(x, t)=\left(u_{1}(x, t), u_{2}(x, t)\right)$. Note that $u_{2}$ represents the flow of the fluid relative to the solid but measured in terms of volume per unit area of the bulk medium $\Omega_{p}$.

Next, the strain tensor in the solid is given by

According to Hooke's law for anisotropic elastic solids, the stress tensor $\sigma_{i j}\left(u_{1}\right)$ is related to $\varepsilon_{i j}\left(u_{1}\right)$ according to

Also, the strain energy density $W_{s}=W_{s}\left(\varepsilon_{i \jmath}\left(u_{1}\right)\right)$ in $\Omega_{s}$ is a quadratic function of $\varepsilon_{l j}\left(u_{1}\right)$ given by

Next, on the set $\Omega_{p}$ the stress-strain relations can be described using a total stress tensor $\tau_{l^{\prime}}(u)$ for the bulk material and the fluid pressure $p(u)$. They are given by [5],

Here $H=H(x)$ is a strictly positive coefficient and the $Q_{\nu j}$ 's are such that $Q_{l j}=Q_{n}$. Methods of measurement of the elastic coefficients $A_{\nu j k \ell}$, $Q_{\imath j}$ and $H$ in (2.3) are discussed in [4]. Now the strain energy density $W_{p}=W_{p}\left(\varepsilon_{l \jmath}\left(u_{1}\right), \nabla . u_{2}\right)$ in $\Omega_{p}$ can be written in the form [5],

It will be assumed that the elastic coefficients $A_{\imath \jmath k \ell}, Q_{l j}$ and $H$ in (2.1) and (2.3) are bounded in modulus by some positive constant and also that they satisfy certain conditions in order that the quadratic forms $W_{s}$ and $W_{p}$ be positive definite. Let $\lambda_{s}(x)$ and $\lambda_{p}(x)$ be the minimum eigenvalues of the symmetric matrices $E_{s}(x) \in R^{6 \times 6}$ and $E_{p}(x) \in R^{7 \times 7}$ associated with the quadratic forms $W_{s}$ and $W_{p}$ respectively and let $\lambda_{l}^{*}=\inf \lambda_{l}(x), i=s, p$. $x \in \bar{\Omega}_{t}$
Physical considerations allow us to assume that $\lambda_{s}^{*}>0$ and $\lambda_{p}^{*}>0$. Also, set

Here $[., .]_{e}$ and $\|.\|_{e}$ denote the usual euclidean inner product and norm in $R^{n}$. In Section 5, necessary and sufficient conditions for the validity of (2.5) and (2.6) will be shown for the case in which $\Omega$ is a two-dimensional transverse anisotropic system.

Next, let $\rho=\rho(x)$ be the total mass density of bulk material in $\Omega$ and let $\rho_{f}=\rho_{f}(x)$ be the mass density of fluid in $\Omega_{p}$ and assume that

Let $u_{1}^{0}(x), v_{1}^{0}(x)$ and $f_{1}(x, t)$ be given for $x \in \Omega$ and $u_{2}^{0}(x), v_{2}^{0}(x)$ and $f_{2}(x, t)$ on $\Omega_{p}$. Set $u^{0}=\left(u_{1}^{0}, u_{2}^{0}\right), v^{0}=\left(v_{1}^{0}, v_{2}^{0}\right), f=\left(f_{1}, f_{2}\right)$. In the above $v_{i}=\left(v_{i 1}, v_{i 2}, v_{i 3}\right)$ denotes the unit outward normal along $\partial \Omega_{i}, i=s, p$, and $\sigma \cdot v_{s}=\left(\sigma_{1} \cdot \nu_{s}, \sigma_{2} \cdot \nu_{s}, \sigma_{3} \cdot \nu_{s}\right), \tau \cdot \nu_{p}=\left(\tau_{1} \cdot \nu_{p}, \tau_{2}, v_{p}\right.$, $\tau_{3} \cdot v_{p}$ ).
TP Equation (2.7.i)) is the standard elastic wave equation for $\Omega_{s}$, while (2.7.ii)) is Biot's low-frequency dynamic equation describing the propagation of elastic waves in anisotropic fluid-saturated porous media in the context of nonuniform porosity [5].
$\mathbb{T}$ Equation (2.9.i)) represents the stress-free condition on $\Gamma_{0}$ and (2.9.ii)) is an absorbing boundary condition for the artificial boundary $\Gamma_{1}$ which is derived in Section 6 , the factor $\mathbb{D}^{1 / 2}$ in the right-hand side of (2.9.ii)) being the square root of the symmetric positive definite matrix $\mathbb{D}$ of (6.2).
$\mathbb{P}$ Next, (2.9.iii)) states the continuity of the stress tensor on $\Gamma_{2}$ and (2.9.iv)) imposes the vanishing of the normal component of the relative movement
between fluid and solid along $\Gamma_{2}$. The last two boundary conditions are used in order to have conservation of energy flux through $\Gamma_{2}$ [11].

For the uniform porosity isotropic case, Biot's dynamic equation (2.7.ii)) is equivalent to that given in [3] and the problem just stated above in (2.7)(2.9) reduces to that treated in [19].

## 3. NOTATIONS AND PRELIMINARIES

For an integer $n \geqslant 1$, denote by $(\cdot, \cdot)_{i}$ and $\|\cdot\|_{0, \Omega_{i}}, i=s, p$, the inner product and norm in $\left[L^{2}\left(\Omega_{i}\right)\right]^{n}$ and by (., .) and $\|\cdot\|_{0}$ the inner product and norm in $\left[L^{2}(\Omega)\right]^{n}$. If the initial values $U^{0}$ and $U^{1}$ needed to initialize the procedure (4.9) are chosen as indicated in [19], then the optimal order of convergence is preserved. This completes the definition and analysis of the numerical methods related to the problem (2.7)-(2.9).

## 5. THE TWO-DIMENSIONAL TRANSVERSE ANISOTROPIC CASE

Here the results obtained in the previous Sections will be applied to the case in which $\Omega$ is a two-dimensional domain and the bulk material is
symmetric with respect to the $x_{2}$-axis in the following sense. Let $\bar{A}_{i j k l}$ and $\bar{Q}_{i j}$ be the tensors in the stress-strain relations (2.1) and (2.3) after a change of coordinates of the form $\bar{x}_{1}=-x_{1}, \bar{x}_{2}=x_{2}$. Then we will assume that

In the above $u_{1}=\left(u_{11}, u_{12}\right)$ is the vector displacement in the solid part of $\Omega$ and $u_{2}=\phi\left(\tilde{u}_{2}-u_{1}\right)=\left(u_{21}, u_{22}\right)$, where $\tilde{u}_{2}=-\left(\tilde{u}_{21}, \tilde{u}_{22}\right)$ represents the average fluid displacement in $\Omega_{p}$. From physical considerations it can be seen that $R_{1}(x), R_{2}(x), A(x), N(x)$ and $H(x)$ are bounded above and below by positive constants. Also, necessary and sufficient conditions for the strain energy densities $W_{s}$ and $W_{p}$ to be positive definite are given by

Next, the symmetric properties of the material imply that matrices $G$ and $\mathbb{K}$ in the definition of the mass matrix $\mathscr{A}$ and the dissipation matrix $\mathscr{C}$ are given by

In order to define this two-dimensional model completely we have to construct the matrix $\mathbb{D}$ of the absorbing boundary condition (2.9.ii)). For that purpose, and as is indicated in Section 6, we obtain the strain energy $\pi$ on the artificial boundary $\Gamma_{1}$ by combining (2.2) and (5.2) to write $W_{s}$ as a quadratic function of $\left(\varepsilon_{l j}\left(u_{1}\right)\right)_{1 \leqslant t, j \leqslant 2}$ and then use (6.1) to substitute $\varepsilon_{i j}\left(u_{1}\right)$ on $\Gamma_{1}$ in terms of $\nu_{s}, \frac{\partial u_{1}}{\partial t}$ and the wave velocity $c$. In this way we get a quadratic function $\pi$ of $\left(\frac{1}{c} \frac{\partial u_{1 ı}}{\partial t}\right)_{1 \leqslant l \leqslant 2}$ which has the following expression :

$$
\begin{aligned}
\pi= & \frac{1}{2}\left[\left(\left(v_{s 1}\right)^{2} R_{1}+\left(v_{s 2}\right)^{2} N\right)\left(\frac{1}{c} \frac{\partial u_{11}}{\partial t}\right)^{2}\right. \\
& +2 v_{s 1} v_{s 2}(A+N) \frac{1}{c} \frac{\partial u_{11}}{\partial t} \frac{1}{c} \frac{\partial u_{12}}{\partial t} \\
& \left.+\left(\left(v_{s 1}\right)^{2} N+\left(v_{s 2}\right)^{2} R_{2}\right)\left(\frac{1}{c} \frac{\partial u_{12}}{\partial t}\right)^{2}\right] .
\end{aligned}
$$

Thus, it follows from (6.2) that

$$
\mathbb{D}=\left[\begin{array}{ll}
\left(v_{s 1}\right)^{2} R_{1}+\left(v_{s 2}\right)^{2} N & v_{s 1} v_{s 2}(A+N) \\
v_{s 1} v_{s 2}(A+N) & \left(v_{s 1}\right)^{2} N+\left(v_{s 2}\right)^{2} R_{2}
\end{array}\right]
$$

Note that when $\Omega$ is a rectangle the matrix $\mathbb{D}$ is diagonal and consequently the boundary conditions (2.9.ii)) have a simple expression in terms of the elastic coefficients $R_{1}$ or $R_{2}$ and $N$.

TP Finally, since we are dealing with a two-dimensional domain, the finite element spaces used for the spatial discretization have to be changed as follows. Let $\mathbf{Y}_{h}=\mathrm{Y}_{h}(\Omega)$ and $\mathbf{Y}_{h}=\mathbf{Y} f\left(\Omega_{p}\right)$ be quasiregular partitions of $\Omega$ and $\Omega_{p}$ respectively into triangles or rectangles of diameter bounded by $h$ and let $m_{h} \subset\left[H^{1}(\Omega)\right]^{2}$ be a standard finite element space associated with $\mathrm{Y}_{h}$ satisfying the approximating hypotheses (4.5). Let $\mathrm{BDM}_{k}$ (respectively, $\mathrm{RT}_{k}$ ) denote the vector part of the Brezzi-Douglas-Marini [1], (respectively, Raviart-Thomas [6], [15], [20]) two-dimensional space of index $k$ associated with $\mathrm{Y}_{h}$ and set ${\underset{\mathrm{BDM}}{k}}^{\mathrm{BO}_{2}}\left\{\left\{q \in \mathrm{BDM}_{k}: q \cdot v_{p}=0\right.\right.$ on $\left.\Gamma_{2}\right\}$, ${\underset{\sim}{\mathrm{T}}}_{k}=$ $\left\{q \in \mathrm{RT}_{k}: q \cdot v_{p}=0\right.$ on $\left.\Gamma_{2}\right\}$. Then $\tilde{V}_{h}$ should be taken to be either
 ropic model is totally defined and the continuous and discrete-time Galerkin procedures (4.8) and (4.9) can be implemented.

## 6. AN ABSORBING BOUNDARY CONDITION FOR ANISOTROPIC ELASTIC SOLIDS

In any realistic seismic model we are led to consider wave propagation in infinite solids. One way of representing an infinite system by a finite one is to introduce non-reflecting artificial boundaries into the finite system.

In this Section we will derive boundary conditions ensuring that most of the energy arriving at the artificial boundary $\Gamma_{1}$ will be absorbed. These boundary conditions will be obtained from the momentum equations of wave fronts arriving normally to $\Gamma_{1}$, thus making it transparent to that kind of waves. For the isotropic case, the equations derived here reduce to those presented in [12] by Lysmer and Kuhlemeyer.

First we will summarize some results given in [10] about the velocity of waves in anisotropic solids. Let us consider a wave arriving normally to $\Gamma_{1}$ with a velocity $c$. The strain tensor on $\Gamma_{1}$ can be written in the form

$$
\begin{equation*}
\varepsilon_{i j}\left(u_{1}^{c}\right)=-\frac{1}{2}\left(v_{s i} \frac{1}{c} \frac{\partial u_{1 j}^{c}}{\partial t}+\nu_{s j} \frac{1}{c} \frac{\partial u_{1 i}^{c}}{\partial t}\right), 1 \leqslant i, j \leqslant 3,(x, t) \in \Gamma_{1} \times J \tag{6.1}
\end{equation*}
$$

Next, let $v^{c}=\frac{1}{c} \frac{\partial u_{1}^{c}}{\partial t}=\left(v_{1}^{c}, v_{2}^{c}, v_{3}^{c}\right)$. Then combining Hooke's law (2.1) and (6.1), the strain energy $W_{s}$ in (2.2) can be written on $\Gamma_{1}$ as a quadratic function $\pi\left(v^{c}\right)=W_{s}\left(\varepsilon_{i j}\left(v^{c}\right)\right)$ in the form

$$
\begin{equation*}
\pi=\frac{1}{2}\left[\mathbb{D} \boldsymbol{v}^{c}, v^{c}\right]_{e}, \quad(x, t) \in \Gamma_{1} \times J \tag{6.2}
\end{equation*}
$$

where $\mathbb{D}(x) \in R^{3 \times 3}$ is a symmetric, positive definite matrix depending on $\nu_{s}$ and the elastic coefficients $A_{i j k \ell}(x)$ in (2.1).

Next, the momentum equation on $\Gamma_{1}$ are

$$
-\rho c \frac{\partial u_{1 k}^{c}}{\partial t}=\sum_{j} \frac{\partial W_{s}}{\partial \varepsilon_{k j}} v_{s j}, \quad 1 \leqslant k \leqslant 3, \quad(x, t) \in \Gamma_{1} \times J .
$$

Also, combining (2.1)-(2.2) and (6.1),

$$
\begin{align*}
\frac{\partial \pi}{\partial v_{k}^{c}} & =\sum_{i, j} \frac{\partial W_{s}}{\partial \varepsilon_{i j}} \frac{\partial \varepsilon_{i j}}{\partial v_{k}^{c}} \\
& =-\sum_{l} \frac{\partial W_{s}}{\partial \varepsilon_{k j}} \nu_{s j}, \quad 1 \leqslant k \leqslant 3 \tag{6.3}
\end{align*}
$$

Thus,

$$
\begin{equation*}
\frac{\partial \pi}{\partial v_{k}^{c}}=\rho c^{2} v_{k}^{c}, \quad 1 \leqslant k \leqslant 3, \quad(x, t) \in \Gamma_{1} \times J \tag{6.4}
\end{equation*}
$$

which in turn implies that $c^{2}$ satisfies the equation

$$
\begin{equation*}
\operatorname{det}\left(\mathbb{D}-\rho c^{2} I\right)=0 . \tag{6.5}
\end{equation*}
$$

Equation (6.5) yields three real positive values for $c^{2}$, so that there are three real wave-velocities, say $\left(c_{k}\right)_{1 \leqslant k \leqslant 3}$, corresponding to any direction of propagation of waves. Equations (6.1)-(6.5) are derived in [10, pp. 295298].
TP Now consider a velocity $\frac{\partial u_{1}}{\partial t}$ on the surface $\Gamma_{1}$ due to the simultaneous normal arrival of waves of possible different velocities $\left(c_{k}\right)_{1 \leqslant k \leqslant 3}$. Let $M$ be the matrix containing, as rows, the eigenvectors $M_{k}$ of $D$ and let $\Lambda$ be the diagonal matrix containing the eigenvalues $\left(\rho c_{k}^{2}\right)_{l \leqslant k \leqslant 3}$ of $D$, so that $D=M^{t} \Lambda M$. Also set $v^{c_{k}}=\frac{1}{c_{k}}\left[M_{k}, \frac{\partial u_{1}}{\partial t}\right]_{e} M_{k}$ and let $\mathscr{F}_{k}$ be the force on $\Gamma_{1}$ corresponding to $v^{c_{k}}$. Then according to (6.4) $\mathscr{F}_{k}$ satisfies the relations

$$
\begin{align*}
\mathscr{F}_{k} & =\frac{\partial \pi}{\partial v^{c_{k}}} \\
& =\rho c_{k}^{2} v^{c_{k}}  \tag{6.6}\\
& =\rho c_{k}\left[M_{k}, \frac{\partial u_{1}}{\partial t}\right]_{e} M_{k} .
\end{align*}
$$

Next we observe that the total energy of waves arriving normally to $\Gamma_{1}$ is the sum of the partial energies $\pi\left(v^{c_{k}}\right)$ and the total force $-\sigma\left(u_{1}\right) . v_{s}$ on $\Gamma_{1}$ is equal to the sum of the partial forces $\mathscr{F}_{k}$. Then, according to (6.6),

$$
\begin{aligned}
-\sigma\left(u_{1}\right) \cdot v_{s} & =-\sum_{k=1}^{3}\left[M_{k}, \sigma\left(u_{1}\right) \cdot v_{s}\right]_{e} M_{k} \\
& =\rho \sum_{k} c_{k}\left[M_{k}, \frac{\partial u_{1}}{\partial t}\right]_{e} M_{k},
\end{aligned}
$$

so that

$$
-\left[M_{k}, \sigma\left(u_{1}\right), v_{s}\right]_{e}=\rho c_{k}\left[M_{k}, \frac{\partial u_{1}}{\partial t}\right]_{e}, \quad 1 \leqslant k \leqslant 3 .
$$

In matrix form the equations above can be written

$$
-M\left(\sigma\left(u_{1}\right) \cdot v_{s}\right)=\rho^{1 / 2} \Lambda^{1 / 2} M \frac{\partial u_{1}}{\partial t}
$$

so that multiplying by $M^{t}$ we finally get

$$
\begin{equation*}
-\sigma\left(u_{1}\right) \cdot v_{s}=\rho^{1 / 2} \mathbb{D}^{1 / 2} \frac{\partial u_{1}}{\partial t}, \quad(x, t) \in \Gamma_{1} \times J \tag{6.7}
\end{equation*}
$$

Using (6.7) as boundary conditions on $\Gamma_{1}$, the conservation of momentum implies that the energy of wave fronts arriving normally to $\Gamma_{1}$ will be absorbed. Note also that when the medium $\Omega_{s}$ is isotropic the diagonal matrix $\Lambda=\left(\Lambda_{i j}\right)$ is given by $\Lambda_{11}=\rho \alpha^{2}, \Lambda_{22}=\Lambda_{33}=\rho \beta^{2}, \alpha$ and $\beta$ being the velocities of the compressional and shear waves, respectively, and that the rows of $M$ contain the unit outward normal and two unit tangent vectors to $\Gamma_{1}$ in that order. Thus, in this case conditions (6.7) reduce to those given in [12] by Lysmer and Kuhlemeyer.
